

**HOUSE COMMITTEE AMENDMENTS**

2022 Regular Session

Amendments proposed by House Committee on Transportation, Highways and Public Works to Engrossed Senate Bill No. 389 by Senator Reese

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 47:296.2(A)," insert "(B), and (D),"

3 AMENDMENT NO. 2

4 On page 1, line 4, after "taxes;" delete "to increase the threshold;" and insert "to provide for  
5 notification requirements; to authorize the secretary of the Department of Revenue to adopt  
6 rules that increase the threshold for suspension in certain circumstances; to authorize  
7 alternatives to suspension;"

8 AMENDMENT NO. 3

9 On page 1, line 16, change "R.S. 47:296.2(A) is" to "R.S. 47:296.2(A), (B), and (D) are"

10 AMENDMENT NO. 4

11 On page 2, line 1, after "suspension" and before "and" insert "**of driving privileges shall be**  
12 **imposed**"

13 AMENDMENT NO. 5

14 On page 2, at the end of line 5, insert "one"

15 AMENDMENT NO. 6

16 On page 2, at the beginning of line 6, delete "**two**"

17 AMENDMENT NO. 7

18 On page 2, line 9, after "**into**" and before "**with**" delete "**a payment plan**" and insert "**an**  
19 **installment agreement**"

20 AMENDMENT NO. 8

21 On page 2, delete line 12 and insert:

22 "B.**(1)** The suspension and denial shall be effective until such time as the  
23 individual has paid or made arrangements to pay the delinquent tax, interest, penalty,  
24 and all costs and the Department of Revenue notifies the Department of Public  
25 Safety and Corrections, office of motor vehicles, of the payment or arrangement to  
26 pay.

27 **(2) Upon payment or arrangement to pay, the Department of Revenue**  
28 **shall promptly notify the office of motor vehicles and the individual's driving**  
29 **privileges shall be reinstated without additional action required of the**  
30 **individual.**

32 D.**(1)** The secretary of the Department of Revenue, in cooperation with the  
33 secretary of the Department of Public Safety and Corrections, shall adopt and  
34 promulgate rules and regulations in accordance with the provisions of the  
35 Administrative Procedure Act to effectuate the orderly and expeditious suspension

1 and denial of renewal and reissuance of drivers' licenses in accordance with the  
2 provisions of this Section.

3 **(2) Notwithstanding the provisions of Subsection A of this Section, the**  
4 **secretary of the Department of Revenue may, by rule, provide for suspension**  
5 **of driver's license privileges at higher thresholds of individual income tax due**  
6 **based on an individual's historical compliance with Louisiana tax laws, the facts**  
7 **and circumstances relating to the unpaid tax liability, and may accept surety or**  
8 **other collateral in lieu of suspension of a driver's license."**
