# EDUCATION ACCOUNTABILITY: Requests the state Department of Education to report on the school and district accountability system

| 6  | WHEREAS, Louisiana law provides for a school and district accountability system              |
| 7  | through which schools and school districts are evaluated and graded based in part on student |
| 8  | achievement; and   |
| 9  | WHEREAS, student achievement is based in part on performance on standardized                 |
| 10 | tests and other assessments; and   |
| 11 | WHEREAS, some elements of the accountability system are products of federal law              |
| 12 | as requisite conditions for the receipt of federal funding; and                              |
| 13 | WHEREAS, in order for the House of Representatives to better evaluate the school             |
| 14 | and district accountability system, it needs better information on how federal law and rules |
| 15 | and state law and rules contribute elements of the current system.                           |
| 16 | THEREFORE, BE IT RESOLVED that the House of Representatives of the                           |
| 17 | Legislature of Louisiana does hereby urge and request the state Department of Education to   |
| 18 | study federal and state requirements regarding the school and district accountability system |
| 19 | and to submit a written report of findings and data supporting such findings to the House of |
| 20 | Representatives by February 10, 2023.  |

- 5 (3) Identify the state law, including rules and regulations, that provide specific
- 6 elements of the school and district accountability system and identify those elements that are
- 7 not required by federal law.
- 8 (4) Identify the aspects of the school and district accountability system that require
- 9 the expenditure of state or local funds.
- 10 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 11 state superintendent of education and the president of the State Board of Elementary and
- 12 Secondary Education.
