2	To amend and reenact R.S. 33:9091.25(B) and (D), relative to Orleans Parish; to provide
3	relative to the Delachaise Security and Improvement District; to provide relative to
4	the boundaries and governance of the district; and to provide for related matters.
5	Notice of intention to introduce this Act has been published.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 33:9091.25(B) and (D) are hereby amended and reenacted to read
8	as follows:
9	§9091.25. Delachaise Security and Improvement District

11	B. Boundaries. The boundaries of the district shall be that area within and
12	including the following perimeter: beginning at the intersection of Louisiana Ave.
13	and Carondelet St. and proceeding along Carondelet St. (both sides) to its
14	intersection with Napoleon Ave., along Napoleon Ave. (interior side) to its
15	intersection with Freret St., then along Freret St. (interior side) to its
16	intersection with Louisiana Ave. Marengo St., along Marengo St. (both sides) to
17	its intersection with S. Saratoga St., then along S. Saratoga St. (both sides) to its
18	intersection with Louisiana Ave., and finally along Louisiana Ave. (interior side)
19	back to its intersection with Carondelet St.

21	D. Governance. (1) The district shall be governed by a board of
22	commissioners, referred to in this Section as the "board", consisting of five seven
23	members, all of whom shall be qualified voters and residents of the district,
24	composed as follows:

#### **ENROLLED**

1	(a) The presidents of the Delachaise Neighborhood Association, referred to
2	in this Section as the "DNA", and the Milan Neighborhood Association,
3	referred to in this Section as the "MNA".
4	(b) The governing board of the <del>Delachaise Neighborhood Association</del> <b>DNA</b>
5	shall appoint three two members who may be members of the governing board.
6	(c) The governing board of the MNA shall appoint two members who
7	may be members of the governing board.
8	(d) The member of the governing authority of the city of New Orleans who
9	represents Council District B shall appoint one member.
10	(2)(a) The member <u>members</u> serving pursuant to Subparagraph $(1)(a)$ of this
11	Subsection shall serve during his their term of office.
12	(b) The members appointed pursuant to Subparagraph $(1)(b)$ <b>and (c)</b> of this
13	Subsection shall serve two-year terms after initial terms as provided in this
14	Subparagraph. Two members shall serve an initial term of one year and one member
15	shall serve an initial term of two years, as determined by lot at the first meeting of
16	the board.
17	(c) The member appointed pursuant to Subparagraph (1)(c) (1)(d) of this
18	Subsection shall serve a term concurrent with the appointing authority.
