1 AMENDMENT NO. 1

2 On page 7, line 9, after "shall" delete the remainder of the line and delete lines 10 through  
3 14 and insert:

4 "either approve the emergency preparedness plan or require changes, amendments,  
5 or other revisions to the emergency preparedness plan. The department shall notify  
6 the nursing home that submitted the plan in electronic format of the department's  
7 decision."

8 AMENDMENT NO. 2

9 On page 7, delete lines 24 through 27, and insert:

10 "emergency preparedness plan, and shall approve the emergency preparedness plan  
11 and issue an approval letter to the nursing home. If the required changes,  
12 amendments, or revisions have not been incorporated, the department shall reject the  
13 emergency preparedness plan and issue a letter of rejection to the nursing home.  
14 The department shall not"

15 AMENDMENT NO. 3

16 On page 10, line 19, after "shall" delete the remainder of the line and delete lines 20 through  
17 24 and insert:

18 "either approve the emergency preparedness plan or require changes, amendments,  
19 or other revisions to the emergency preparedness plan. The department shall notify  
20 the nursing home that submitted the plan in electronic format of the department's  
21 decision."

22 AMENDMENT NO. 4

23 On page 11, delete lines 6 through 9, and insert:

24 "emergency preparedness plan, and shall approve the emergency preparedness plan  
25 and issue an approval letter to the nursing home. If the required changes,  
26 amendments, or revisions have not been incorporated, the department shall reject the  
27 emergency preparedness plan and issue a letter of rejection to the nursing home.  
28 The department shall not"

29 AMENDMENT NO. 5

30 On page 14, line 26, after "shall" delete the remainder of the line and delete lines 27 through  
31 29 and insert:

32 "either approve the emergency preparedness plan or require changes, amendments,  
33 or other revisions to the emergency preparedness plan. On or before March first, the  
34 department shall notify the nursing home that submitted the plan in electronic format  
35 of the department's decision."

36 AMENDMENT NO. 6

37 On page 15, delete lines 1 and 2

2 On page 15, delete lines 12 through 15, and insert:

3 "emergency preparedness plan, and shall approve the emergency preparedness plan  
4 and issue an approval letter to the nursing home. If the required changes,  
5 amendments, or revisions have not been incorporated, the department shall reject the  
6 emergency preparedness plan and issue a letter of rejection to the nursing home. The  
7 department shall issue"
