Provides for changes to the Water Sector Program. (gov sig)

Proposed law provides for application period dates. This bill directs the Division of Administration (DOA) to conduct outreach and educational efforts for all water and sewer systems to raise awareness regarding the Water Sector Program (WSP). It also directs the DOA to post on its website a copy of the guidance regarding the WSP, including the application process, procurement or scoring criteria upon request of the commission. Proposed law establishes the WSP to provide grant funding for repairs, improvements, and consolidation of community water and sewer systems. Proposed law provides that the DOA, Office of Facility Planning and Control, and the Office of Community Development shall administer the program in consultation with the LA Department of Health (LDH) and the LA Department of Environmental Quality (DEQ). Proposed law directs the DOA to establish a specific working panel to review and rate applications submitted by community water systems, community sewer systems, and local governing authorities and submit recommendations for funding to this commission. Proposed law directs the commission to submit recommendations for grant awards amounts to the Joint Legislative Committee on the Budget. Proposed law provides for proposed matching funds requirements and provides for certain waivers of matching funds or decreased match for any project based on the specific determinations.
