2	To urge and request the State Civil Service Commission to consult with and advise the LSU
3	Health Sciences Center New Orleans and LSU Health Sciences Center Shreveport
4	on the feasibility and desirability of participating in the state employee leave transfer
5	program.
6	WHEREAS, Part V of Chapter 8 of Title 42 of the Louisiana Revised Statutes of
7	1950 provides for the state employee leave transfer program; and
8	WHEREAS, the state employee leave transfer program allows full-time employees
9	of state agencies to contribute excess annual, sick, and compensatory leave to a pool which
10	then may be used by any participating employee for a personal emergency upon the
11	exhaustion of his or her personal leave balance; and
12	WHEREAS, many employees find themselves in need of additional leave during the
13	course of their employment due to a variety of circumstances such as providing care for a
14	loved one, the birth of a child, or personal illness; and
15	WHEREAS, many campuses within the LSU system have implemented policies that
16	allow their employees to participate in the program; and
17	WHEREAS, information regarding the adoption and implementation of a policy to
18	allow employees of the LSU Health Sciences Center New Orleans and LSU Health Sciences
19	Shreveport to participate in the state employee leave transfer program will allow for
20	productive discussions and informed decision-making by the appropriate administrators.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the 2 Legislature of Louisiana does hereby urge and request the State Civil Service Commission 3 to consult with and advise the LSU Health Sciences Center New Orleans and LSU Health 4 Sciences Center Shreveport on the feasibility and desirability of participating in the state 5 employee leave transfer program. 6 BE IT FURTHER RESOLVED that LSU Health Sciences Center New Orleans and 7 LSU Health Sciences Center Shreveport shall send a report to the chairman of the House 8 Committee on House and Governmental Affairs on their discussions relative to participating 9 in the program and any steps taken toward its implementation by February 1, 2023. 10 BE IT FURTHER RESOLVED that copies of this Resolution be transmitted to the 11 chancellors of LSU Health Sciences Center New Orleans and LSU Health Sciences Center 12 Shreveport and the president of the Board of Supervisors of Louisiana State University and
