HOUSE BILL NO. 647

1 AN ACT

2 To amend and reenact R.S. 33:9091.14(D)(1), (2), (4), (5), and (6), relative to Orleans
3 Parish; to provide relative to the Mid-City Security District; to provide relative to the
4 governing board of the district; to provide relative to the membership of the board;
5 to provide relative to board appointments and officers; to provide for an effective
6 date; and to provide for related matters.

7 Notice of intention to introduce this Act has been published
8 as provided by Article III, Section 13 of the Constitution of
9 Louisiana.

10 Be it enacted by the Legislature of Louisiana:

11 Section 1. R.S. 33:9091.14(D)(1), (2), (4), (5), and (6) are hereby amended and
12 reenacted to read as follows:

13 §9091.14. Mid-City Security District

14 * * *

15 D. Governance. (1) The district shall be governed by a ~~five-member~~ seven-
16 member board of commissioners, referred to in this Section as the "board". The
17 board shall be composed as follows:

18 (a) The Mid-City Neighborhood Organization or its successor shall appoint
19 four members, ~~one of whom shall be from the City Park Triangle.~~

20 (b) The ~~Parkview Neighborhood Association~~ City Park Neighborhood
21 Association or its successor shall appoint ~~one member~~ three members.

22 (2) All members appointed pursuant to ~~Paragraph (1)~~ Paragraphs (1) and (4)
23 of this Subsection shall be qualified voters and residents of the district.

24 * * *

25 (4)(a) Any vacancy which occurs prior to the expiration of the term for
26 which a member of the board has been appointed shall be filled for the remainder of

1 the unexpired term in the same manner as the original appointment. If the appointing
2 authority responsible for the appointment of a member fails to fill a vacancy within
3 thirty days, the remaining members of the board shall appoint an interim successor
4 to serve until the position is filled by the appointing authority.

5 (b) Board members shall be eligible for reappointment; however, board
6 members shall serve for no more than two consecutive three-year terms. A board
7 member shall be eligible for reappointment to the commission two years from the
8 date of expiration of his second term.

9 (5) The board shall elect from its members a chairman, a vice chairman, a
10 ~~secretary-treasurer~~ secretary, a treasurer, and such other officers as it may deem
11 necessary. The offices of secretary and treasurer may be held by the same person.
12 The duties of the officers shall be fixed by the bylaws adopted by the board.

13 (6) The minute books and archives of the district shall be maintained by the
14 ~~secretary-treasurer~~ secretary of the board. The monies, funds, and accounts of the
15 district shall be in the official custody of the board.

16 * * *

17 Section 2. This Act shall become effective upon signature by the governor or, if not
18 signed by the governor, upon expiration of the time for bills to become law without signature
19 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
20 vetoed by the governor and subsequently approved by the legislature, this Act shall become
21 effective on the day following such approval.
