1	AN ACT
2	To amend and reenact R.S. 44:4.1(B)(26) and to enact R.S. 40:2193.6, relative to pediatric
3	day health care facilities licensed by the Louisiana Department of Health; to require
4	that such facilities install cameras at their licensed premises; to require such facilities
5	to develop and disseminate policies concerning cameras installed at their premises;
6	to provide requirements and limitations with respect to the location and placement
7	of such cameras; to provide authorizations and restrictions with respect to video and
8	audio recordings made by such cameras; to exempt such video and audio recordings
9	from the provisions of the Public Records Law; to provide for an effective date; and
10	to provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 40:2193.6 is hereby enacted to read as follows:
13	§2193.6. Cameras; condition of licensure
14	A. Each pediatric day health care facility shall provide for the installation
15	and operation at its licensed premises of cameras that record both video and audio.
16	Compliance with the provisions of this Section shall be a condition of a pediatric day
17	health care facility's licensure by the department as provided in this Part.
18	B. The director of each pediatric day health care facility shall develop and
19	share with all facility employees and parents of children served at the facility a
20	policy relative to cameras at the facility that, at minimum, provides for all of the
21	following:

1	(1) The location and placement of cameras in any room, except a location
2	identified in Paragraph (2) of this Subsection, in which children may be cared for.
3	(2) A prohibition against the recording of the interior of a restroom or any
4	other area in which a child's bare body is normally exposed.
5	(3) A requirement that written notice of the cameras be provided to facility
6	employees, parents of children served at the facility, and authorized visitors.
7	(4) A requirement that all employees who provide services at the facility
8	receive training concerning the provisions of this Section.
9	(5) Provisions relative to the duration of retention of video and audio data
10	recorded by the devices required by this Section and procedures for data storage and
11	disposal.
12	(6) Procedures for protecting children's privacy and for determining to whom
13	and under what circumstances video or audio data may be disclosed. Such policies
14	shall restrict authorization to review video or audio data recorded by the devices
15	required by this Section to the following persons, exclusively:
16	(a) The director of the pediatric day health care facility.
17	(b) The secretary of the department or his designee.
18	(c) A parent of a recorded child pursuant to an allegation or evidence of
19	abuse, neglect, or injury.
20	(d) Any member of law enforcement while investigating, in his official
21	capacity, an allegation or evidence of abuse, neglect, or injury.
22	(e) Any party designated in a subpoena issued by a court of law.
23	(7) A requirement that any person who views a recording showing what he
24	believes could be a violation of state or federal law shall report the suspected
25	violation to the appropriate law enforcement agency.
26	(8) A requirement that any camera installed pursuant to this Section be in
27	compliance with the National Fire Protection Association Life Safety Code.
28	C. Recordings made by cameras at pediatric day health care facilities
29	installed and operated in accordance with this Section shall be kept confidential and

The legislature further recognizes that there exist exceptions, exemptions, 7 and limitations to the laws pertaining to public records throughout the revised 8 statutes and codes of this state. The requirements enacted by Section 1 of this Act relating to installation 18 and operation of cameras at pediatric day health care facilities shall not become enforceable 19 until the date of adoption of administrative rules promulgated by the Louisiana Department 20 of Health for implementation of the provisions of this Act. 21 Section 4.
