WATERWAYS: Establishes the Acadiana Watershed District

1	AN ACT
2	To amend and reenact the heading of Chapter 17 of Title 38 of the Louisiana Revised
3	Statutes of 1950 and to enact R.S. 38:3321 through 3327, relative to the Acadiana
4	Watershed District; to create and provide for the Acadiana Watershed District; to
5	provide for the boundaries and purposes of the district; to create and provide for a
6	board of commissioners of the district; to provide for the composition, powers, and
7	duties of the board, including the authority to levy taxes within the district; to
8	provide for reports; to provide relative to the district's relationship with the
9	Department of Transportation and Development and the Coastal Protection and
10	Restoration Authority; and to provide for related matters.
11	Notice of intention to introduce this Act has been published
12	as provided by Article III, Section 13 of the Constitution of
13	Louisiana.
14	Be it enacted by the Legislature of Louisiana:
15	Section 1. The heading of Chapter 17 of Title 38 of the Louisiana Revised Statutes
16	of 1950 is hereby amended and reenacted and R.S. 38:3321 through 3327 are hereby enacted
17	to read as follows:

1	CHAPTER 17. SOUTH TERREBONNE PARISH TIDEWATER MANAGEMENT	
2	AND CONSERVATION DISTRICT ACADIANA WATERSHED DISTRICT	
3	<u>§3321. Creation; boundaries</u>	
4	The Acadiana Watershed District, referred to in this Chapter as the "district"	
5	is hereby created. The district shall lie within the Atchafalaya, Mermentau,	
6	Mermentau Headwaters, Teche, and Vermilion watersheds, situated in the parishes	
7	of Acadia, Allen, Avoyelles, Calcasieu, Cameron, Evangeline, Iberia, Iberville,	
8	Jefferson Davis, Lafayette, Point Coupee, Rapides, St. Landry, St. Martin, St. Mary,	
9	and Vermilion. The district boundaries within those parishes shall be aligned with	
10	the geographic area composed of Hydrologic Unit Subbasins 08080101, 08080102,	
11	08080103, 08080201 and 08080202, as defined by the United States Geological	
12	Survey Watershed Boundary Dataset as of August 1, 2023. The Louisiana	
13	Watershed Flood Center at the University of Louisiana at Lafayette, in consultation	
14	with the office of state lands and the Coastal Protection and Restoration Authority,	
15	shall submit to the legislature a detailed legal description of the Acadiana Watershed	
16	District boundaries by January 1, 2024.	
17	§3322. Purpose	
18	The purpose of the district shall be to do the following:	
19	(1) Promote and support a unified effort to address drainage and flood issues	
20	in the region in cooperation with local, state, and federal agencies.	
21	(2) Participate in any activity designed and conducted to promote drainage	
22	and flood risk reduction within the boundaries of the district.	
23	(3) Identify local public sources of revenue or expenditure that may be used	
24	to draw down federal matching funds for the provision of drainage projects to reduce	
25	flood risk.	
26	(4) Cooperate with local, state, and federal organizations and agencies	
27	engaged in planning and construction of drainage and flood reduction and mitigation	
28	projects in the state and region.	

1	(5) Cooperate with local and state organizations and agencies engaged in	
2	establishing best practice development standards for flood-risk reduction and	
3	mitigation in the region.	
4	§3323. Corporate status; domicile	
5	A. The district shall constitute a body corporate in law and shall be a	
6	political subdivision of the state. The district may incur debt and contractual	
7	obligations in accordance with law, sue and be sued, purchase and sell property, have	
8	a corporate seal, and do and perform any and all acts in its corporate capacity and in	
9	its corporate name which are necessary and proper for carrying out the purposes and	
10	objects for which it is created.	
11	B. The district shall be domiciled and shall establish an office for the	
12	transaction of its business operations at a location within Lafayette Parish and central	
13	to the boundaries of the district.	
14	C. The district may own, operate, and maintain a regional sensor network to	
15	inform water management practices.	
16	D. The district shall recognize the Louisiana Watershed Flood Center as a	
17	center of excellence for watershed management for purposes of serving as a	
18	community resource and an authority on research-based data including but not	
19	limited to hydraulic and hydrologic data, watershed models, and innovative	
20	watershed practices.	
21	E. The district shall be the primary and official repository for all data and	
22	models developed for Hydrologic Unit Subbasins 08080101, 08080102, 08080103,	
23	08080201, and 08080202 and shall also receive, own, operate, and maintain the LWI	
24	Region 5 hydrologic and hydraulic models and any derivative work therein.	
25	F. The district shall be audited pursuant to R.S. 24:513.	
26	§3324. Board of commissioners; appointments; terms; vacancies	
27	A. The board of commissioners of the Acadiana Watershed District, referred	
28	to in this Chapter as the "board", is hereby created. The governance, control, and	
29	management of the affairs of the district shall be vested in the board.	

1	B. The board shall be comprised of the following members:
2	(1) The police jury presidents of the parishes of Acadia, Allen, Avoyelles,
3	Calcasieu, Cameron, Evangeline, Jefferson Davis, Rapides, and Vermillion, or their
4	respective designees.
5	(2) The mayor-president of Lafayette Parish or his designee.
6	(3) The parish presidents of the parishes of Iberia, Iberville, Pointe Coupee,
7	St. Landry, St. Martin, and St. Mary, or their respective designees.
8	C. The board may appoint a technical advisory committee to advise the
9	board on scientific, engineering, and other technical matters. Committee members
10	shall not have voting rights on the board of commissioners. The committee shall be
11	composed of the following members, who shall be nominated by their respective
12	constituent organizations:
13	(1) A representative of the Soil & Water Conservation District IV.
14	(2) A representative of the Teche-Vermilion Fresh Water District.
15	(3) A representative of the Louisiana Watershed Flood Center.
16	(4) A representative of the Louisiana Natural Resources Conservation
17	Service of the United States Department of Agriculture Natural Resources
18	Conservation Division.
19	(5) Two at-large members appointed by a municipality or municipalities with
20	a population of thirty thousand or more and meeting the technical qualification
21	requirements described in this Section.
22	(6) Two at-large members appointed by a municipality or municipalities with
23	a population of less than thirty thousand and meeting the technical qualification
24	requirements described in this Section.
25	(7) One member appointed by the secretary of the Department of
26	Transportation and Development.
27	(8) One member appointed by the executive director of the Coastal
28	Protection and Restoration Authority.

1	(9) One member appointed by the commander and district engineer of the
2	New Orleans District, United States Army Corps of Engineers.
3	D. Members of the board shall serve terms concurrent with their term of
4	office. Members of the technical advisory committee shall serve terms of three
5	years, with the initial terms staggered in accordance with the board's bylaws.
6	E. Members of the board and the technical advisory committee shall reside
7	within the boundaries of the district or any parish within which a portion of the
8	district lies.
9	F. Designees and technical appointees shall have professional experience in
10	engineering, project management, certified flood plain management, or other
11	drainage-related field such as geosciences, hydrology, or water management.
12	§3325. Officers; vacancies; compensation
13	A. The commissioners shall elect from their membership a chairman, a vice
14	chairman, and a secretary-treasurer. The duties of the officers shall be fixed by the
15	bylaws adopted by the board.
16	B. Any vacancy which occurs in the membership of the board shall be filled
17	in the same manner as required for the member being replaced.
18	C. The commissioners shall serve without compensation, except per diem
19	or expense reimbursement to which they may be individually entitled as members
20	of their constituent organizations.
21	D. All commissioners shall be subject to the Code of Governmental Ethics.
22	§3326. Bylaws; quorum
23	A. The board shall adopt such bylaws as it deems necessary or advisable for
24	conducting its business affairs by January 1, 2024. Such bylaws shall include, but
25	not be limited to the following:
26	(1) Procedures for the election of officers, including initial terms of office
27	and methods and grounds for removal of officers.

1	(2) Procedures and grounds for removal of commissioners, which shall	
2	include, but not be limited to, felony conviction and failure of the commissioner to	
3	meet board attendance requirements.	
4	(3) Frequency of meetings.	
5	(4) Appointment of standing and special committees as necessary to carry	
6	out the purposes of this Chapter.	
7	B. Before entering upon his official duties, each member of the board shall	
8	take the oath of office provided by Article X, Section 30 of the Constitution of	
9	Louisiana before an officer authorized by law to administer oaths.	
10	C. A majority of the membership of the board shall constitute a quorum for	
11	the transaction of business.	
12	§3327. Powers and duties of the board	
13	A. In order to accomplish the purposes for which the district is created, the	
14	board may purchase, acquire by donation, hold, sell, and convey immovable and	
15	movable property and execute such contracts as it may deem necessary or convenient	
16	to enable it to properly carry out the purposes for which it is created.	
17	B. Notwithstanding any provision of law to the contrary, the board may	
18	accept the transfer or donation of funds from the governing authorities of parishes,	
19	municipalities, drainage districts, levee districts, and other political subdivisions in	
20	the district.	
21	C. Notwithstanding any provision of law to the contrary, the board may	
22	contract with the federal government, the state, or any other public or private entity	
23	to receive and expend funds to plan and perform projects for watershed management.	
24	D. The board may levy a district drainage tax on all property within the	
25	boundaries of the district subject to taxation for drainage purposes. The tax shall not	
26	be levied unless the proposition to levy the tax is approved by a majority of the	
27	electors within the district boundaries who vote on the proposition.	
28	E. In addition to the duties defined elsewhere in this Chapter, the board shall	
29	have the duty and authority to do the following:

1	(1) Represent the public interest in supporting drainage, flood reduction, and	
2	mitigation in the district.	
3	(2) Advise state and local government agencies on issues concerning	
4	drainage, and the reduction and mitigation of flood risk in the district.	
5	(3) Conduct public hearings and share public input on the community's	
6	priorities relative to drainage, flood risk, and mitigation in the district.	
7	(4) Enter into contracts, agreements, or cooperative endeavors with the state	
8	and its political subdivisions and with any public or private person to promote the	
9	public purposes of the district.	
10	(5) Construct and maintain drainage works of all types, either in cooperation	
11	with public entities within the boundaries of the district, or upon its own undertaking.	
12	Notwithstanding any other provision of this Chapter to the contrary, all works	
13	undertaken pursuant to the authority granted by this Section shall be performed in	
14	accordance with the provisions of R.S. 38:2211, et seq. Construction projects shall	
15	require approval of two-thirds of the total voting membership of the board. All other	
16	decisions, including technical, planning, and permitting decisions, shall require	
17	approval by a simple majority of the total voting membership.	
18	(6) Develop and recommend watershed management practices and regional	
19	guidance within the district, insofar as those practices affect watershed management,	
20	that address the following:	
21	(a) Planning.	
22	(b) Permitting.	
23	(c) Selection of and performing projects and programs.	
24	(d) Resolution of conflicts among agencies.	
25	(e) Use of best available science.	
26	(f) Outreach to the public and state and federal agencies.	
27	(g) Coordination with state agencies and political subdivisions regarding	
28	watershed management.	

1	(h) Identifying, obtaining, and expending funding for planning and projects,	
2	and entering into agreements with public and private entities.	
3	(i) Entering into agreements with public and private entities to identify,	
4	obtain, and expend funds.	
5	(j) Assisting political subdivisions in planning, designing, and constructing	
6	projects, and identifying and obtaining funding.	
7	(k) Maintaining completed projects and programs.	
8	(1) Defining qualifications for staff and contractors.	
9	F. The board may develop a regional hazard mitigation plan consistent with	
10	parish hazard mitigation plans.	
11	G. The board shall consider the benefits of participating in the National	
12	Flood Insurance Program Community Rating System (CRS) or any successor or	
13	similar program, including how to maximize municipal participation in the CRS. The	
14	board shall also consider and prioritize other available policies and programs that can	
15	reduce flood risk and reduce flood insurance premiums.	
16	H. The board may develop and implement a plan to manage and maintain	
17	any waterways in the district, of state or regional concern, in relation to matters	
18	impacting the district, in coordination with other federal, state, and local water	
19	management jurisdictions and authorities.	
20	I. The board shall develop a master plan for comprehensive drainage, flood	
21	control, and water resource management through the construction and management	
22	of projects and programs, including planning, permitting, development, and	
23	waterway management. The plan should consider the Coastal Protection and	
24	Restoration Authority Master Plan and provide for public outreach.	
25	J. The board, with the approval of the representative parish governing	
26	authorities, shall appoint an administrative body to carry out the purposes of this	
27	Chapter.	
28	K. The division of administration, Department of Transportation and	
29	Development, and the Coastal Protection and Restoration Authority shall not

Abstract: Creates the Acadiana Watershed District and provides for its boundaries, purpose, governance, authority to levy taxes within the district, and relation to other public entities related to watershed management.

<u>Proposed law</u> establishes the Acadiana Watershed District, provides for its purpose, and defines its geographic boundaries.

<u>Proposed law</u> provides for the district's corporate status, authority to incur debt, domicile, ownership, operation, and maintenance of a regional sensor network, and for recognition of the La. Watershed Flood Center at UL-Lafayette as a regional data resource.

<u>Proposed law</u> provides for the responsibilities and auditing of the district and for its use, storage, and maintenance of the LWI Region 5 hydrologic and hydraulic model.

<u>Proposed law</u> establishes a board of commissioners to govern and manage the affairs of the district to be composed of the following members:

- (1) The police jury presidents of the parishes of Acadia, Allen, Avoyelles, Calcasieu, Cameron, Evangeline, Jefferson Davis, Rapides, and Vermillion, or their respective designees.
- (2) The mayor-president of Lafayette Parish or his designee.
- (3) The parish presidents of the parishes of Iberia, Iberville, Pointe Coupee, St. Landry, St. Martin, and St. Mary, or their respective designees.

<u>Proposed law</u> provides for the creation of bylaws, for meetings, compensation, terms of service, and vacancies.

<u>Proposed law</u> authorizes the board to establish a technical advisory committee comprised of the following members:

- (1) A representative of the Soil & Water Conservation District IV.
- (2) A representative of the Teche-Vermilion Fresh Water District.
- (3) A representative of the La. Watershed Flood Center.
- (4) A representative of the La. Natural Resources Conservation Service of the U.S. Dept. of Agriculture Natural Resources Conservation Division.
- (5) Two at-large members appointed by a municipality or municipalities with a population of thirty thousand or more and meeting the technical qualifications requirements described in this Section.

- (6) Two at-large members appointed by a municipality or municipalities with a population of less than thirty thousand and meeting the technical qualification requirements described in this Section.
- (7) One member appointed by the secretary of the Dept. of Transportation and Development (DOTD).
- (8) One member appointed by the executive director of the Coastal Protection and Restoration Authority (CPRA).
- (9) One member appointed by the Commander and District Engineer of the New Orleans District, U.S. Army Corps of Engineers.

<u>Proposed law</u> provides for the powers of the board of commissioners, including that to acquire funding and property, to contract with public and private entities, to levy taxes on any property within the district subject to taxation, to advise state and local government on drainage and flooding issues, to conduct public hearings, to construct and maintain drainage works, to develop and recommend regional planning and practice guidance, and to develop and implement a waterway management plan and a comprehensive drainage, flood control, and water resource management plan.

<u>Proposed law</u> authorizes the district to develop a regional hazard mitigation plan that is consistent with parish hazard mitigation plans.

<u>Proposed law</u> precludes the division of administration, DOTD and the CPRA from displacing, replacing, or supplanting district funding.

(Amends the heading of Chapter 17 of Title 38; Adds R.S. 38:3321-3327)
