1 §523. Americans with Disabilities Act compliance officer

2 A. The secretary of state shall appoint an Americans with Disabilities Act
3 compliance officer to serve at the pleasure of the secretary. The secretary shall fix
4 the salary of the compliance officer.

5 B. The responsibilities and duties of the officer shall include:

6 (1) To serve as a primary point of contact for election day accessibility
7 issues.

8 (2) To conduct and issue a biannual accessibility audit. The officer shall
9 issue a report of his findings to the secretary, the commissioner of elections, and the
10 Voting Accessibility Advisory Group. The report shall be posted on the department
11 website.

12 (3) To facilitate meetings of the Voting Accessibility Advisory Group.

13 (4) To perform any additional responsibilities and duties assigned by the
14 secretary.

15 §523.1. Voting Accessibility Advisory Group

16 A. The Voting Accessibility Advisory Group is created and established in
17 the Department of State. The group shall be comprised of at least seven members,
18 a majority of which shall be disabled and represent a diversity of accessibility needs.

19 B. The group shall consult on voting accessibility issues including but not
20 limited to:

21 (1) Improving election commissioner training, specifically related to
22 compliance with the Americans with Disabilities Act of 1990, as amended (42
23 U.S.C. 12101 et seq.) and assisting voters with disabilities.

24 (2) Improving accessibility in voting systems.

25 (3) Creating publications of best practices related to accessible voting for
26 local election officials.

27 (4) Revising and improving the department's publications and postings at
28 voting locations.

29 (5) Increasing accessibility of information on the department's website.

1 Section 2. R.S. 36:744(C)(5) is hereby enacted to read as follows:

2 §744. Transfer of boards, commissions, and agencies to the Department of State

4 C. The following agencies are placed within the Department of State in
5 accordance with the provisions of R.S. 36:901 et seq. except as otherwise provided
6 by this Subsection:

8 (5) Voting Accessibility Advisory Group (R.S. 18:523.1).

10 Section 3. This Act shall become effective upon signature by the governor or, if not
11 signed by the governor, upon expiration of the time for bills to become law without signature
12 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
13 vetoed by the governor and subsequently approved by the legislature, this Act shall become
14 effective on the day following such approval.

Abstract: Provides for an Americans with Disabilities Act officer appointed by the secretary of state, a Voting Accessibility Advisory Group within the Dept. of State, and the instruction and examination of elections commissioners relative to the rights of voters with disabilities.

Present law (R.S. 18:431) requires the clerk of court to conduct a general course of instruction for election commissioners. Further requires the clerk to provide specific instruction during the course pursuant to minimum standards issued by the secretary of state.

Proposed law retains present law and further requires the clerk to provide instruction on the duty to comply with provisions of law pertaining to the rights of voters with disabilities, including the Americans with Disabilities Act.

Present law (R.S. 18:431.1) requires the secretary of state to prepare the examination to be used for the course of instruction for commissioners and commissioners-in-charge. Further requires that the examination include questions relating to certain matters.

Proposed law retains present law and further requires the secretary to include in the examination questions relating to procedures for assisting voters with disabilities and

requirements to comply with provisions of law pertaining to the rights of voters with disabilities, including the Americans with Disabilities Act.

Proposed law (R.S. 18:523) requires the secretary of state to appoint an American with Disabilities Act compliance officer to serve at the pleasure of the secretary. Provides that the secretary shall fix the salary of the compliance officer and assigns responsibilities and duties to the officer.

Proposed law (R.S. 18:532.1) creates the Voting Accessibility Advisory Group within the Dept. of State. Provides that the group shall be comprised of at least seven members, a majority of which shall be disabled and represent a diversity of accessibility needs. Further provides that the group shall consult on voting accessibility issues.

Effective upon signature of governor or lapse of time for gubernatorial action.
