| 4 | WHEREAS, the Louisiana Sports Hall of Fame in Natchitoches, Louisiana, each year |
| 5 | collaborates with the Louisiana Sports Writers Association in selecting a limited number of |
| 6 | sports figures who embody the character, skill, and talent worthy of being named to the Hall |
| 7 | of Fame; and |
| 8 | WHEREAS, the 2023 Louisiana Sports Hall of Fame Induction Class includes Matt |
| 9 | Forte; and |
| 10 | WHEREAS, Matt Forte grew up in Slidell, Louisiana, and graduated from Slidell |
| 11 | High School in 2004, where he was a letterman in football and track & field; and |
| 12 | WHEREAS, Matt played National Collegiate Athletic Association (NCAA) Division |
| 13 | I college football at Tulane University in New Orleans; in 2007, he was the only Bowl |
| 14 | Championship Series non-automatic qualification conference athlete to be a semifinalist for |
| 15 | both the Maxwell and Doak Walker Awards, named to the Walter Camp Player of the Year |
| 16 | List, and one of just three players nationally named to all three lists; and |
| 17 | WHEREAS, Matt had a breakout season as a senior with a school-record 2,127 |
| 18 | rushing yards and averaged 5.9 yards per carry with a school-record of 23 touchdowns; and |

| 1 | whereas, a two-time An-Comerence USA pick, Mait garnered attention at the |

| 2 | 2008 Senior Bowl in Mobile, Alabama, walking away with the Overall Most Valuable Player |
| 3 | award and leading with 59 yards rushing on eight carries, four receptions for 38 yards and |
| 4 | a tackle on special teams; and |
| 5 | WHEREAS, the Chicago Bears drafted Matt in the second round of the 2008 |
| 6 | National Football League (NFL) Draft as the 44th overall selection, the sixth running back |
| 7 | taken that year; and |
| 8 | WHEREAS, Matt was one of the NFL's top dual threat running backs during his 10- |
| 9 | year career with the Chicago Bears (2008 to 2015) and New York Jets (2016 and 2017); and |
| 10 | WHEREAS, Matt made two Pro Bowl appearances (2011 and 2013), was named to |
| 11 | the 2008 NFL All-Rookie Team, named Diet Pepsi NFL Rookie of the Week in 2008, |
| 12 | National Football Conference Player of the Week in 2010, became a five-time 1,000-yard |
| 13 | rusher, and is one of three running backs in NFL history with 1,000 rushing yards and 100 |
| 14 | catches in a season; and |
| 15 | WHEREAS, Matt was ranked 34th by the Chicago Bears on their list of the top 100 |
| 16 | greatest Bears of all-time; he holds three franchise rookie season records: most rush attempts |
| 17 | (316), most receptions (63), most yards from scrimmage (1,715), and shares franchise |
| 18 | records with most receptions, postseason game, and games with at least three touchdowns |
| 19 | in a season; and |
| 20 | WHEREAS, on February 28, 2018, at the age of 32, Matt Forte announced his |
| 21 | retirement from the NFL after playing for 10 seasons, and on April 23, 2018, the Chicago |
| 22 | Bears honored Matt Forte with a signed ceremonial one-day contract to retire as a member |
| 23 | of the Bears. |
| 24 | THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana |
| 25 | does hereby commend Matt Forte on being inducted into the 2023 class of the Louisiana |
| 26 | Sports Hall of Fame. |
| 27 | BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to Matt |
| 28 | Forte. |
