2 On page 2, line 8, after "in the" delete the remainder of the line and delete line 9 in its  
3 entirety and insert the following:

4 "Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (42  
5 U.S.C. 11302)."

6 AMENDMENT NO. 2

7 On page 2, at the beginning of line 10, change "C.(1)" to "C."

8 AMENDMENT NO. 3

9 On page 2, at the beginning of line 12, delete "(a)" and insert the following:

10 "(1) To develop a statewide plan to end homelessness, which shall include  
11 and address the following:

12 (a) Identification and analysis of the particular challenges and barriers that  
13 cause people in Louisiana to become at risk of homelessness, to experience  
14 homelessness, and to be unable to return to housing.

15 (b) Assessment of factors that contribute to episodes and rates of  
16 homelessness at the individual, community, and state levels.

17 (c) Proposed actions and policies to address the challenges, barriers, and  
18 factors that contribute to homelessness.

24 On page 2, line 22, after "homelessness" change the comma "," to a period "." and delete the  
25 remainder of the line and delete line 23 in its entirety

27 On page 2, line 24 after "The" delete the remainder of the line

29 On page 3, line 4, after "Department of" and before "Corrections" insert "Public Safety and"

30 AMENDMENT NO. 8

31 On page 3, line 5, after "Health" and before "or his" delete "and Hospitals"

33 On page 3, delete lines 6 through 8 in their entirety and insert the following:

- 3                    care to end homelessness programs located in Louisiana appointed by the governing
- 4                    board of each continuum of care.

32   On page 4, line 26, after "facilities, and" delete the remainder of the line and insert

33   "resources to facilitate remote participation in meetings to the extent authorized by law."
