Abstract: Repeals certain funds provided for in the constitution.

<u>Present constitution</u> establishes the Atchafalaya Basin Conservation Fund and provides for deposits and uses of monies in such fund in Article VII, Section 4(D)(4)(b). The fund was established to fund projects under the Atchafalaya Basin Program within the Coastal Protection and Restoration Authority. Provides for implementation of the fund contingent upon certain conditions being met.

Proposed constitutional amendment repeals present constitution.

<u>Present constitution</u> establishes the Higher Education Louisiana Partnership Fund and provides for deposits into and uses of monies in such fund in Article VII, Section 10.4.

Proposed constitutional amendment repeals present constitution.

<u>Present constitution</u> establishes the Millennium Leverage Fund and provides for deposits into and uses of monies in such fund in Article VII, Section 10.10.

Proposed constitutional amendment repeals present constitution.

<u>Present constitution</u> establishes the Agricultural and Seafood Products Support Fund and provides for deposits and uses of monies in such fund in Article VII, Section 10.12.

Proposed constitutional amendment repeals present constitution.

<u>Present constitution</u> establishes the First Use Tax Trust Fund and provides for deposits and uses of monies in such fund in Article IX, Section 9.

Proposed constitutional amendment repeals present constitution.

<u>Present constitution</u> establishes the Louisiana Investment Fund for Enhancement and provides for deposits into and uses of monies in such fund in Article IX, Section 10.

Proposed constitutional amendment repeals present constitution.

Provides for submission of the proposed amendment to the voters at the statewide election to be held October 14, 2023.
