1 Section 2. This Act shall become effective upon signature by the governor or, if not

2 signed by the governor, upon expiration of the time for bills to become law without signature

3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

- 4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 5 effective on the day following such approval.

<u>Present law</u> provides that when any communications district is created wholly within a single parish, the parish governing authority creating it may appoint a board of commissioners composed of seven members to govern its affairs and shall fix the domicile of the board at any point within the parish.

<u>Proposed law</u> retains <u>present law</u> but provides that members of the East Baton Rouge Parish Communications District board may appoint a proxy in the event a member of the board cannot attend a meeting.

Effective upon signature of the governor or lapse of time for gubernatorial action.
