(b) The Louisiana State Board of Private Security Examiners shall be entitled 11 12 to the criminal history record and identification files of the bureau on those persons 13 seeking to be licensed as private security guards or registered by the board as a means of performing background checks on those individuals. A fee of twenty-six 14 15 dollars shall be charged for furnishing said records. In addition, in order to 16 determine an applicant's eligibility or suitability for licensure or registration under the provisions of the Private Security Regulatory and Licensing Law, each applicant 17 shall be fingerprinted and the fingerprints shall be forwarded by the bureau to the 18 19 Federal Bureau of Investigation for a national criminal history record check. 20
