Purpose of Bill: This bill requires that every clerk of court provide information to the Louisiana Clerks' Remote Access Authority (LCRAA) about the software, electronic filing capabilities, costs, and funding required to complete an integrated electronic filing system for their parish. This information will be compiled be LCRAA and submitted to the Legislature by January 1, 2024. Furthermore, the LCRAA is required to develop an integrated electronic filing system that all clerks of courts must have in place by January 1, 2025. The system is to include electronic document filing, case management, and document and image management capabilities. The bill requires existing recording fees to be used to fund this system. All documents in a civil, traffic, or criminal action filed by an attorney must be transmitted electronically using this system starting January 1, 2025. Additionally, this bill expands the LCRAA board of commissioners from 7 to 11 members, adding 1 justice of the Louisiana Supreme Court and 3 judges from district courts.

EXPENDITURE EXPLANATION

This bill may increase local fund expenditures for Clerks of Courts and LCRAA by an indeterminable amount.

Information gathered from LCRAA, the Louisiana Clerks of Court Association, and various parish Clerks of Court indicates that there may be increased costs to develop and implement the statewide integrated electronic filing system provided for by this bill by January 1, 2025 (equipment, software development, etc.).

One of the requirements of this bill is that every Clerk of Court provide information to the LCRAA about the software, electronic filing capabilities, costs, and funding required to complete an integrated electronic filing system for their parish. Therefore, it appears that overall cost estimates would have to be considered and reported to LCRAA in order to estimate an overall fiscal impact.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.

In order to provide fiscal background information, the LCRAA's FY 2022 Audit reported \$2,027,955 in fee receipts from members.
