26 27 As used in this Chapter, unless the context clearly indicates otherwise, the following definitions shall apply:

* *

(2) "Department" means the Department of Transportation and Development <u>Commerce</u>.

(3) "Joint committee" means the House Committee on Transportation, Highways and Public Works <u>Commerce</u> and the Senate Committee on Transportation, Highways and Public Works <u>Commerce, Consumer Protection</u> <u>and International Affairs</u>, functioning as a joint legislative committee <u>meeting</u> jointly.

§3455. Projects undertaken by the department

28 A. After adoption of the department's recommendations by the joint 29 committee, the approved list of projects shall be forwarded to the department for implementation. The approved list shall be implemented by the department by the 30 use of funds appropriated, funding obligation authority, or pursuant to the cash 31 management program as provided by R.S. 48:251(D). Funding or funding obligation 32 33 authority shall be allocated to projects in accordance with the prioritized list of 34 projects approved by the joint committee. Funding obligation authority may be granted or authorized for a project from funds appropriated or obligated for another 35 36 project or projects within the Port Priority Construction and Development Program 37 provided that such authority does not impede such project or projects. Such funding obligation authority shall be extinguished for a project at such time as funds are 38 39 made available for obligation for the project. The department shall not delete, add, 40 or substitute any projects for those approved by the joint committee, except as 41 provided in R.S. 34:3456; however, the secretary of the department may, at his

- discretion, authorize projects to be undertaken and financed due to an emergency out
 of the secretary's emergency fund.
