3 before "to" insert "to expand the prohibition against the use of wireless telecommunication  
4 devices while operating a motor vehicle in school zones to the general operation of a motor  
5 vehicle;"

7 On page 3, line 20, after "devices" and before "prohibited" delete "in school zones"

9 On page 4, line 1, after "(2)" delete the parenthesis ")"

10 AMENDMENT NO. 4

11 On page 4, line 10, after the period "." change "Wireless" to "Wireless"

12 AMENDMENT NO. 5

13 On page 4, line 11, after "motor" delete the remainder of the line and insert " vehicle: nor  
14 shall it"

6 On page 6, line 19, after "dollars" delete the remainder of the line and insert a period "."

9 AMENDMENT NO. 16

10 On page 6, line 23, after "than" delete the remainder of the line and insert "one hundred  
11 dollars."

12 AMENDMENT NO. 17

13 On page 6, delete lines 24 through 29 in their entirety and insert in lieu thereof "The third  
14 and any subsequent violation of the provisions of this Section shall be punishable by a fine  
15 of not more than one hundred dollars."

16 AMENDMENT NO. 18

17 On page 7, delete lines 1 through 4 in their entirety

18 AMENDMENT NO. 19

19 On page 7, delete lines 18 and 19 in their entirety and insert in lieu thereof the following:

20 "(5) For any violation of this Section, a law enforcement officer may issue  
21 a citation but shall not arrest the motorist."

23 On page 8, delete lines 21 and 22 in their entirety and insert in lieu thereof the following:

24 "F. A law enforcement officer shall not search or inspect a motor vehicle, its  
25 contents, the driver, or a passenger solely because of a violation of this Section."
