1 AMENDMENT NO. 1

2 On page 1, line 17, after "1950," and before "shall" insert the following:

3 "or by a person holding a permit issued pursuant to Chapter 1 and
4 Chapter 2 of Title 26 of the Louisiana Revised Statutes of 1950 where beverages
5 of either high or low alcoholic content are the principal commodity sold or
6 served to the public for consumption on the permit holder's premises."

7 AMENDMENT NO. 2

8 On page 2, line 11, after "1950," and before "shall" insert the following:

9 "or by a person holding a permit issued pursuant to Chapter 1 and
10 Chapter 2 of Title 26 of the Louisiana Revised Statutes of 1950 where beverages
11 of either high or low alcoholic content are the principal commodity sold or
12 served to the public for consumption on the permit holder's premises"

13 AMENDMENT NO. 3

18 served to the public for consumption on the permit holder's premises."

19 AMENDMENT NO. 4

21 "(4) If the person under the age for the lawful purchase of intoxicating
22 beverages of either high or low alcoholic content misrepresents his age by
23 submitting any one of the means of identification or similar means of
24 verification provided through the use of a real-time age verification system
25 authorized by the commissioner pursuant to R.S. 26:90(A)(1) or 286(A)(1)(a) to
26 obtain alcoholic beverages or to gain entry to licensed premises, the right of
27 action otherwise authorized by this Subsection shall not exist."
