SPECIAL DAY/WEEK/MONTH: Designates May 17, 2023, as Bankers Day at the state capitol

1 A RESOLUTION

2 To designate Wednesday, May 17, 2023, as Bankers Day at the state capitol.

3 WHEREAS, since 1900, the Louisiana Bankers Association, or LBA, has diligently
4 represented the interests of banks and thrifts operating in the state of Louisiana; and

5 WHEREAS, LBA is a member-driven organization that works to provide bankers
6 with the tools to serve their customers and communities; and

7 WHEREAS, the LBA's current membership represents one hundred seventeen
8 institutions, which include state and federal charters, small and large institutions, and locally
9 based community banks; and

10 WHEREAS, LBA is guided by its board of directors, which includes Joseph F.
11 Quinlan, III of First National Bankers Bankshares, Inc., chairman; Brian North of Fifth
12 District Savings Bank, chairman-elect; Michael Vizard with Cross Keys Bank, treasurer;
