CRIME/MISDEMEANOR: Establishes penalties associated with minors swimming in certain waterways without personal flotation devices

AN ACT

2	To enact R.S. 14:93.2.4, relative to criminal liability for certain acts of minors; to create the
3	crime of unlawful swimming in certain waterways; to provide for penalties; and to
4	provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 14:93.2.4 is hereby enacted to read as follows:
7	§93.2.4. Unlawful swimming in certain waterways
8	A. It shall be unlawful for any parent or legal guardian who has care and
9	control of a minor, to permit a minor, either knowingly, wilfully, or through criminal
10	negligence to swim in any river that generates hydroelectric power without wearing
11	a Type I, Type II, Type III, or Type V personal flotation device approved by the
12	United States Coast Guard.
13	B.(1) On a first conviction, the parent or legal guardian shall be issued a
14	warning ticket, fined not more than twenty-five dollars, or both.
15	(2) On a second conviction, the parent or legal guardian shall be fined not
16	more than fifty dollars, imprisoned for not more than seven days, or both.
17	(3) On a third or subsequent conviction, the parent or legal guardian shall be
18	fined not more than seventy-five dollars nor more than two hundred fifty dollars,
19	imprisoned for not more than thirty days, or both.

**Abstract:** Creates the crime of unlawful swimming in certain waterways and provides for penalties.

<u>Proposed law</u> provides that it shall be unlawful for any parent or legal guardian who has care and control of a minor, to permit a minor, either knowingly, wilfully, or through criminal negligence to swim in any river that generates hydroelectric power without wearing a Type I, Type II, Type III, or Type V personal flotation device approved by the U.S. Coast Guard.

## <u>Proposed law</u> provides for the following penalties:

- (1) On a first conviction, the parent or legal guardian shall be issued a warning ticket, fined not more than \$25, or both.
- On a second conviction, the parent or legal guardian shall be fined not more than \$50, imprisoned for not more than seven days, or both.
- (3) On a third or subsequent conviction, the parent or legal guardian shall be fined not more than \$75 nor more than \$250, imprisoned for not more than 30 days, or both.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Administration of Criminal Justice</u> to the <u>original</u> bill:

- 1. Make technical changes.
- 2. Change criminal responsibility <u>from</u> the minor <u>to</u> the parent or legal guardian.
- 3. Change the elements to provide that a parent or legal guardian has to have care and control of the minor and permits the minor, either knowingly, willfully, or through criminal negligence to swim in any river that generates hydroelectric power without wearing an approved personal flotation device approved by the U.S. Coast Guard.
- 4. Change the penalties as follows:
  - (a) On a first conviction, the parent or legal guardian shall be issued a warning ticket, fined not more than \$25, or both.
  - (b) On a second conviction, the parent or legal guardian shall be fined not more than \$50, imprisoned for not more than seven days, or both.
  - (c) On a third or subsequent conviction, the parent or legal guardian shall be fined not more than \$75 nor more than \$250, imprisoned for not more than 30 days, or both.
