14 ~~have been permitted by the office and placed at a location which has been approved~~
15 ~~by the office on or prior to August 15, 2008; or~~

16 ~~(b) The licensed distributor has delivered to the office or has sent by certified~~
17 ~~mail an application with the required fees to have electronic video bingo machines~~
18 ~~permitted, which application has been received, but not approved by the office on or~~
19 ~~prior to August 15, 2008, and the application includes one of the following:~~

20 ~~(i) Proof of purchase for the total number of video bingo machines to be~~
21 ~~placed at a specific location.~~

22 ~~(ii) A nonrefundable deposit of a minimum of twenty-five percent of the fair~~
23 ~~market value of the wholesale purchase price of the total number of machines to be~~
24 ~~placed at a specific location.~~

25 ~~(iii) A nonrefundable deposit on a lease agreement which is equivalent in~~
26 ~~value to a minimum of twenty-five percent of the fair market value of the wholesale~~
27 ~~purchase price of the total number of machines to be placed at a specific location.~~

28 ~~(2) Electronic video bingo machines authorized by the provisions of this~~
29 ~~Subsection shall only be placed at one of the following locations:~~

30 ~~(a) A location which has been approved by the office on or prior to August~~
31 ~~15, 2008; or~~

32 ~~(b) A location for which a completed application with the required fees for~~
33 ~~the licensing to conduct charitable gaming at a specific location has been received~~
34 ~~by the office on or prior to August 15, 2008. However, locations which have not~~
35 ~~been approved by the office prior to August 15, 2008, but for which an application~~
36 ~~has been timely filed as provided by this Subparagraph, shall have received final~~
37 ~~approval from the office and must be occupied by August 15, 2009, in order to~~
38 ~~operate electronic video bingo machines which are not in compliance with the~~
39 ~~provisions of R.S. 4:724(B)(5).~~

40 **(3) The office shall not issue any license or permit to any location or to**
41 **any distributor for use of electronic bingo machines after June 30, 2022.**
