14 "12(a) "Sale" means any transfer of title or possession, or both, exchange, 15 barter, conditional or otherwise, in any manner or by any means whatsoever, of tangible personal property, for a consideration, and includes the fabrication of 16 17 tangible personal property for consumers who furnish, either directly or indirectly, 18 the materials used in fabrication work, and the furnishing, preparing or serving, for 19 a consideration, of any tangible personal property, consumed on the premises of the 20 person furnishing, preparing or serving such tangible personal property. A 21 transaction whereby the possession of property is transferred but the seller retains 22 title as security for the payment of the price shall be deemed a sale.

(b) Solely for the purposes of sales and use tax levied by the state and
 political subdivisions, "sale" shall not include the fabrication of photos or videos
 delivered electronically through the internet or via email or by USB flash drive,
 digital versatile disk, compact disk, or tapes. The invoice for the electronically
 delivered photos or videos along with photography or videography services
 must be in a lump sum, not separately stated. This Subparagraph shall not
 apply to photo books, portraits, prints, film reels, or video books.
