- 1 AMENDMENT NO. 1
- 2 On page 2, line 16, after "<u>application</u>" and before "<u>any</u>" change "<u>from</u>" to "<u>on</u>"
- 3 AMENDMENT NO. 2
- 4 On page 2, delete lines 18 through 19 in their entirety and insert the following:

5 "(2) The office of technology services shall notify the agency head of each 6 executive branch agency of the policy developed and approved pursuant to this 7 Subsection when the office becomes aware that the agency is in possession of a 8 computer, device, or network owned or leased by the state and shall make the policy 9 available to any agency upon request by the agency."

- 11 On page 2, at the beginning of line 20, change " $\underline{B}$ ." to "(3)"
- 12 AMENDMENT NO. 4
- 13 On page 2, line 20, after "<u>of an</u>" and before "<u>agency</u>" insert "<u>executive branch</u>"
- 14 AMENDMENT NO. 5
- 15 On page 2, line 22, after "to this" change "Section." to "Subsection."
- 16 AMENDMENT NO. 6
- 17 On page 2, between lines 22 and 23, insert the following:

18 "B. The supreme court shall develop and implement a policy to prohibit the 19 use of any covered application on any computer, device, or network owned or leased 20 by the state and used by a judicial branch agency. The policy shall be substantially 21 similar to the policy adopted and approved pursuant to Subsection A of this Section. C. The Joint Legislative Committee on Technology and Cybersecurity shall 22 23 develop a policy to prohibit the use of any covered application on any computer, 24 device, or network owned or leased by the state and used by a legislative branch agency. The policy shall be substantially similar to the policy adopted and approved 25 26 pursuant to Subsection A of this Section. The Legislative Budgetary Control Council 27 shall oversee the implementation of the policy."

- 29 On page 2, at the beginning of line 23, change "<u>C. The</u>" to "<u>D. Any</u>"
- 30 AMENDMENT NO. 8
- 31 On page 3, line 4, after "<u>implement</u>" and before "<u>policy</u>" change "<u>the</u>" to "<u>a</u>"
- 32 AMENDMENT NO. 9
- 33 On page 3, at the end of line 7, insert the following:

"The civil penalty may be recovered by the state in a civil action instituted by the attorney general."
