ECONOMIC DEVELOP/DEPT: Provides for the Louisiana Department of Economic Development to establish and administer the Louisiana Industrial Product Certification Program

AN ACT

2	To enact Part VI of Chapter 3 of Title 51 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 51:971 through 978, relative to the Louisiana Industrial Product
4	Certification Act; to provide for a purpose; to provide for definitions; to provide for
5	a certification program regarding industrial products; to provide for certification
6	eligibility and criteria; to provide for a certification application and evaluation
7	process; to provide for certification compliance monitoring and certification renewal;
8	to provide for an effective date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Part VI of Chapter 3 of Title 51 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 51:971 through 978, is hereby enacted to read as follows:
12	PART VI. LOUISIANA INDUSTRIAL PRODUCT CERTIFICATION ACT
13	§971. Short title
14	This Part shall be known and may be cited as the "Louisiana Industrial
15	Product Certification Act".
16	§972. Purpose
17	The purpose of this Part is to establish a certification program to promote and
18	recognize industrial products that are one hundred percent made in Louisiana,
19	encourage economic growth and development within the state, and support local
20	manufacturers.

2	For the purposes of this Part, the following definitions apply:
3	(1) "Certification" means the formal recognition granted by the state of
4	Louisiana that an industrial product is one hundred percent made in this state.
5	(2) "Department" means the Department of Economic Development.
6	(3) "Industrial product" means any good or material produced for
7	commercial or industrial purposes.
8	(4) "Made in Louisiana" means the production process of an industrial
9	product occurring entirely within this state.
10	§974. Louisiana Industrial Product Certification Program
11	A. The department shall establish and administer the Louisiana Industrial
12	Product Certification Program in accordance with the provisions of this Part.
13	B. The department shall create and maintain a publicly accessible database
14	of certified industrial products.
15	C. The department shall develop a "Made in Louisiana" logo or mark that
16	can be used by manufacturers and producers of certified industrial products.
17	§975. Certification eligibility and criteria
18	To be eligible for certification, an industrial product shall meet all of the
19	following criteria:
20	(1) The entirety of the manufacturing process for the industrial product shall
21	occur within the boundaries of this state, without regard to the geographical source
22	of any components, parts, or materials employed in its production.
23	(2) The manufacturer or producer shall be in compliance with all applicable
24	local, state, and federal environmental, labor, and safety regulations.
25	§976. Application and evaluation process
26	A. A manufacturer or producer seeking certification for its industrial
27	products shall submit an application to the department, which shall include all of the
28	following:
29	(1) A detailed description of the industrial product and its manufacturing
30	process.

1	(2) A comprehensive list of all components, parts, or materials used in the
2	production of the industrial product, including the source and cost of each item.
3	(3) Documentation demonstrating compliance with the eligibility criteria set
4	forth in R.S. 51:975.
5	B. The department shall evaluate each application and may request
6	additional information or conduct site visits as necessary.
7	C. The department shall either grant or deny certification within sixty days
8	of receiving a completed application.
9	D. The department may establish a reasonable fee for processing applications
10	to cover administrative costs.
11	§977. Compliance monitoring and certification renewal
12	A. The department shall periodically monitor the compliance of certified
13	industrial products with the eligibility criteria set forth in R.S. 51:975.
14	B. Certification shall be valid for two years from the date of issuance, and
15	manufacturers or producers may reapply for certification upon expiration.
16	§978. Penalties and enforcement
17	A. A manufacturer or producer found to be using the "Made in Louisiana"
18	logo or mark on noncertified industrial products or falsely claiming certification shall
19	be subject to penalties as determined by the department.
20	B. The department may revoke certification for any industrial product found
21	to be in violation of the eligibility criteria set forth in R.S. 51:975.

REENGROSSED HB NO. 531

<u>Proposed law</u> requires that the Louisiana Industrial Product Certification Program (LIPCP) be established and administered by Dept. of Economic Development (LED).

<u>Proposed law</u> requires that LED create and maintain a publicly accessible database of certified industrial products and that it develop a "Made in Louisiana" logo or mark that can be used by manufacturers and producers of certified industrial products.

<u>Proposed law</u> requires that to be eligible for certification, an industrial product shall meet all of the following criteria:

- (1) The entirety of the manufacturing process for this industrial product shall occur within the boundaries of Louisiana, without regard to the geographical source of any components, parts, or materials employed in said production.
- (2) The manufacturer or producer shall be in compliance with all applicable local, state, and federal environmental, labor, and safety regulations.

<u>Proposed law</u> requires that manufacturers or producers seeking certification for their industrial products shall submit an application to LED, which shall include all of the following:

- (1) A detailed description of the industrial product and its manufacturing process.
- (2) A comprehensive list of all components, parts, or materials used in the production of the industrial product, including the source and cost of each item.
- (3) Documentation demonstrating compliance with the eligibility criteria set forth in proposed law.

<u>Proposed law</u> requires LED evaluate each application, grant or deny certification within 60 days, request additional information or conduct site visits as necessary, and establish a reasonable processing fee.

<u>Proposed law</u> requires LED to monitor the compliance of certified industrial products and revoke certification for any industrial product found to be in violation of the eligibility criteria set forth in <u>proposed law</u>.

Proposed law outlines that a certification will be valid for two years.

<u>Proposed law</u> requires that LED penalizes manufacturers or producers found to be using the "Made in Louisiana" logo or mark on noncertified industrial products or falsely claiming certification.

Summary of Amendments Adopted by House

The House Floor Amendments to the engrossed bill:

1. Clarify that upon expiration of the "Made in Louisiana" certification, manufacturers or producers may reapply for certification.
