Proposed resolution creates a task force to study and make recommendations for designating a certain percentage of man-hours in any apprenticeable occupation to registered apprentices for certain construction and capital projects. The task force is required to convene its first meeting by September 1, 2023 and meet as frequently as it deems necessary. The task force is to present recommended legislation and policy changes for the 2024 Regular Session of the Legislature.

EXPENDITURE EXPLANATION

Proposed resolution is anticipated to have a negligible impact on SGF in FY 24. This measure authorizes the task force to meet until February 1, 2024, when its findings and recommendations are due to the Legislature. Members serve without compensation, aside from the legislative per diem costs paid to four legislators serving on the task force. The legislative per diem rate is \$175/day (\$700 for four members per meeting).

Proposed resolution requires the Louisiana Workforce Commission (LWC) to provide staff support as needed by the task force. LWC has a full-time Director of Apprenticeship and staff who will be able to comply with the requirements of the resolution in the normal course and scope of their duties.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
