#### HOUSE BILL NO. 578

#### BY REPRESENTATIVE GLOVER

1	AN ACT
2	To enact R.S. 22:1041.1 and R.S. 40:1295, relative to a smoking cessation benefits
3	program; to establish and promote a program to assist with smoking cessation; to
4	provide for health insurance and Medicaid coverage for smoking cessation benefits;
5	to provide for the promulgation of rules and regulations; to provide for definitions;
6	to provide for an effective date; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 22:1041.1 is hereby enacted to read as follows:
9	§1041.1. Smoking cessation benefits; coverage
10	A.(1) Any health coverage plan delivered or issued for delivery in this state
11	shall include coverage for smoking cessation benefits for a minimum period of six
12	months if a licensed physician recommends and certifies that the smoking cessation
13	benefits may help the person to quit smoking.
14	(2) The coverage required in this Section shall not be subject to annual
15	deductibles, coinsurance, copayment, or any other out-of-pocket or cost-sharing
16	expense provisions.
17	B. For purposes of this Section, the following definitions apply:
18	(1) "Health coverage plan" means any hospital, health, or medical expense
19	insurance policy, hospital or medical service contract, employee welfare benefit plan,
20	contract, or other agreement with a health maintenance organization or a preferred
21	provider organization, health and accident insurance policy, or any other insurance

12	A. For the purposes of this Section, the following terms have the following
13	meanings:
14	(1) "Department" means the Louisiana Department of Health.
15	(2) "Medical assistance program" means the medical assistance program
16	provided for in Title XIX of the Social Security Act as administered by the Louisiana
17	Department of Health.
18	(3) "Smoking cessation benefits" means smoking cessation treatments and
19	services, including individual counseling, group counseling, nicotine patches,
20	nicotine gum, nicotine lozenges, nicotine nasal spray, nicotine inhaler, bupropion,
21	and varenicline.
22	B.(1) The smoking cessation benefits provided for in R.S. 22:1041.1 shall be
23	a covered service in the medical assistance program.
24	(2) The smoking cessation benefits coverage required by this Subsection
25	shall not be subject to any co-payments, deductibles, or other cost-sharing
26	mechanisms.
27	C. The department shall promulgate and enforce such rules, regulations, and
28	minimum standards as needed to carry out the provisions of this Section.
29	Section 3. The provisions of Section 1 of this Act shall apply to any new policy,
30	contract, program, or health coverage plan issued on and after January 1, 2024. Any policy,

- 1 contract, or health coverage plan in effect prior to January 1, 2024, shall convert to conform
- 2 to the provisions of this Act on or before the renewal date, but no later than January 1, 2025.
