| 7 | Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members |
| 8 | elected to each house concurring, that there shall be submitted to the electors of the state of |
| 9 | Louisiana, for their approval or rejection in the manner provided by law, a proposal to add |
| 10 | Article XI, Section 6 of the Constitution of Louisiana, to read as follows: |
| 11 | §6. Use of Monies, Goods, or Services for Conduct of Elections; Prohibitions |
| 12 | Section 6. No funds, goods, or services donated by a foreign government or |
| 13 | a nongovernmental source shall be used to conduct elections unless provided for in |
| 14 | the election code and subject to restrictions provided by general law. |
| 15 | Section 2. Be it further resolved that this proposed amendment shall be submitted |
| 16 | to the electors of the state of Louisiana at the statewide election to be held on October 14, |
| 17 | 2023. |
| 18 | Section 3. Be it further resolved that on the official ballot to be used at the election, |
| 19 | there shall be printed a proposition, upon which the electors of the state shall be permitted |
| 20 | to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as |
| 21 | follows: |
