1 AN ACT 2 To amend and reenact R.S. 3:4602(4) and (29), relative to weighing and measuring devices; 3 to add "electricity disbursed by electric vehicle supply equipment" and "electric 4 vehicle supply equipment" to certain definitions; to provide for an effective date; and 5 to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 3:4602(4) and (29) are hereby amended and reenacted to read as 8 follows: 9 §4602. Definitions 10 As used in this Chapter, the following terms shall have the following 11 meanings: 12 13 (4) "Commercial weighing and measuring device" means any weight, 14 measure, or weighing or measuring device commercially used or employed in 15 establishing the size, quantity, extent, area, time, distance, or measurement of 16 quantities, things, produce, or articles for distribution or consumption, purchased, 17 offered, or submitted for sale, hire or award, or in computing any basic charge or 18 payment for services rendered on the basis of weight or measure. Except as 19 otherwise provided, the term shall include scales, weighing devices, and metering 20 and measuring devices commercially used for determining the weight or amount of 21 petroleum products, as well as electricity disbursed by electric vehicle supply 22 equipment. It shall also include any accessory attached to or used in connection with

1	a commercial weighing or measuring device when such accessory is so designed or
2	installed that its operation affects the accuracy of the device.

4	(29) "Weights, measures, and weighing and measuring devices" includes all
5	weights, scales, beams, measures of every kind, instruments and mechanical devices
6	for weighing or measuring, scanners or scanning devices that determine product
7	identity and price at the point of sale, electric vehicle supply equipment, and any
8	appliances and accessories connected with any such instruments. However, it does
9	not include or refer to devices used to meter or measure, other than by weight, water,
10	natural or manufactured gas, or electricity, except for electricity used in connection
11	with electric vehicle supply equipment.
12	Section 2. This Act shall become effective upon signature by the governor or, if not
13	signed by the governor, upon expiration of the time for bills to become law without signature
14	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
15	vetoed by the governor and subsequently approved by the legislature, this Act shall become
16	effective on the day following such approval.
