CONTROLLED SUBSTANCES: Provides relative to distribution of fentanyl to minors (Item #24)

AN ACT

2 To enact R.S. 40:967.1, relative to controlled dangerous substances; to provide for the 3 unlawful distribution of fentanyl to minors; to provide for a penalty; to provide for 4 definitions; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 40:967.1 is hereby enacted to read as follows: 7 §967.1. Prohibited acts--Schedule II; distribution to minors 8 A. Any person who violates the provisions of R.S. 40:967(A) in a manner 9 where there is reasonable appeal to a minor due to the shape, color, taste, or design 10 of the fentanyl or the fentanyl's packaging shall be imprisoned at hard labor for not 11 less than twenty-five years nor more than ninety-nine years without benefit of 12 probation, parole, or suspension of sentence. 13 B. For the purposes of this Section, the following definitions shall apply: 14 (1) "Fentanyl" shall mean a substance or mixture containing a detectable 15 amount of fentanyl or its analogues, or carfentanil or a mixture or substance 16 containing a detectable amount of carfentanil or its analogues. (2) "Reasonable appeal" shall mean a design of the fentanyl or the fentanyl's 17 18 packaging, including but not to limited to a resemblance of any of the following: 19 (a) A noncontrolled substance that is primarily consumed by and marketed 20 to minors.

**Abstract:** Prohibits the distribution of fentanyl to minors.

<u>Proposed law</u> provides that any person who violates the provisions of <u>present law</u> (R.S. 40:967(A)) in a manner where there is reasonable appeal to a minor due to the shape, color, taste, or design of the fentanyl or the fentanyl's packaging shall be imprisoned at hard labor for not less than 25 years nor more than 99 years without benefit of probation, parole, or suspension of sentence.

Proposed law defines the terms "fentanyl" and "reasonable appeal".
