COASTAL RESOURCES: (Constitutional Amendment) Provides relative to the disposition of funds derived from alternative energy production in the coastal area

2	Proposing to amend Article VII, Section 10.2(E)(1) of the Constitution of Louisiana, relative	
3	to federal proceeds from alternative energy production on the Outer Continental	
4	Shelf; to provide for the disposition of revenues; to provide for submission of the	
5	proposed amendment to the electors; and to provide for related matters.	
6	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members	
7	elected to each house concurring, that there shall be submitted to the electors of the state of	
8	Louisiana, for their approval or rejection in the manner provided by law, a proposal to	
9	amend Article VII, Section 10.2(E)(1) of the Constitution of Louisiana, to read as follows:

Abstract: Provides that federal revenues received by the state and generated from Outer Continental Shelf alternative or renewable energy production be deposited into the Coastal Protection and Restoration Fund.

<u>Present constitution</u> requires that the treasurer deposit annually into the Coastal Protection and Restoration Fund the federal revenues received by the state from Outer Continental Shelf oil and gas activity.

<u>Proposed constitutional amendment</u> retains <u>present constitution</u> requirements and adds federal revenues generated from Outer Continental Shelf alternative or renewable energy production sources, including wind energy, solar energy, tidal energy, wave energy, geothermal energy, and other alternative or renewable energy production or sources.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 5, 2023.
