15 **§463.231. Special prestige license plate; "Special Need Advocacy, Support and**
16 **Inclusion for all Abilities"**

17 **A.(1) The secretary of the Department of Public Safety and Corrections**
18 **shall establish a special prestige motor vehicle license plate to be known as the**
19 **"Special Needs Advocacy, Support and Inclusion for All Abilities" plate, provided there is a minimum of one thousand applicants for such plate. The**
20 **plate shall be restricted to use on passenger cars, pickup trucks, recreational**
21 **vehicles, motorcycles, and vans.**

23 **(2)The Department of Public Safety and Corrections, office of motor**
24 **vehicles, shall create the special prestige license plate when the applicable**
25 **statutory provisions are met and the department's electronic vehicle and title**
26 **registration system is updated to accommodate the creation of new plates.**

27 **B. The secretary shall work in conjunction with the president of The Arc**
28 **Baton Rouge to select the color and design of the plate, provided it is in**
29 **compliance with R.S. 47:463(A)(3). The design shall include the words "Special**
30 **Needs Advocacy, Support and Inclusion for All Abilities".**

31 **C. The special prestige license plate shall be issued upon application to**
32 **any citizen of Louisiana certified as a member of The Arc Baton Rouge in the**
33 **same manner as any other motor vehicle license plate.**

34 **D. The department shall collect an annual royalty fee of twenty-five**
35 **dollars that shall be disbursed in accordance with Subsection E of this Section.**
36 **This royalty fee shall be in addition to the standard motor vehicle license tax**
37 **imposed by Article VII, Section 5 of the Constitution of Louisiana, and a**
38 **handling fee of three dollars and fifty cents for each plate to be retained by the**
39 **department to offset a portion of administrative costs.**

40 **E. The annual royalty fee shall be collected by the department and**
41 **forwarded to The Arc Baton Rouge. The monies received from the royalty fees**
42 **shall be used to provide advocacy, services and support for Louisiana children**
43 **and adults with special needs and of all abilities.**
