Purpose of Bill: This bill increases nine existing fees collected by the Louisiana Board of Chiropractic Examiners (Board) related to licenses, certificates, and examinations.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

This measure may increase agency self-generated revenues for the Board by \$138,250 annually, depending on the number of transactions per year and when the fee increases go into effect.

A Board official indicated that, based on historical data, the fee increases provided by the bill may increase Board revenue by \$138,250 annually, depending on the number of transactions per year and when the fee increases go into effect. Below is a summary of how each fee increase contributes to the overall revenue increase:

Fee	Revenue Increase	Calculation
Application fee for license to practice	\$ 3,300	22 applications x \$ 150 fee increase
Issuing duplicate certificate/license	\$ 300	10 duplicates x \$ 30 fee increase
Annual license renewal certificate	\$ 120,000	800 certificates x \$ 150 fee increase
License by reciprocity	\$ 750	5 licenses x \$ 150 fee increase
Inactive license renewal	\$ 1,250	50 renewals x \$ 25 fee increase
Chiropractic X-ray assistant certificate	\$ 1,875	75 certificates x \$ 25 fee increase
Delinquent fee	\$ 2,000	20 renewals x \$ 100 fee increase
Examination retake application fee	\$ 25	1 application x \$ 25 fee increase
Annual X-ray certificate registration	\$ 8,750	350 certificates x \$ 25 fee increase
