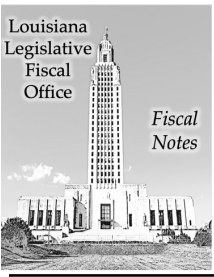

Requires support services for individuals with dementia

Present law provides that the Louisiana Department of Health (LDH) may, in its existing public health programs and services, educate healthcare providers on effective care planning and cognitive assessment tools for patients with Alzheimer's disease and other dementia diseases. Proposed law requires LDH to provide this education. Present law also provides that the LDH Office of Public Health (OPH) may include provisions in its public health outreach programs that address Alzheimer's disease and other dementia disease awareness, detection, and data reporting. Proposed law requires OPH to include these provisions in its public health outreach programs.
