
SENATE COMMITTEE AMENDMENTS

Amendments proposed by Senate Committee on Finance to Engrossed Senate Bill No. 235
by Senator Hensgens

1 AMENDMENT NO. 1

2 On page 1, at the end of line 2, insert "and Subpart CC of Part II-A of Chapter 1 of Subtitle
3 I of Title 39 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 39:100.241,"

4 AMENDMENT NO. 2

5 On page 1, line 5, after "allocation;" insert "to create the Louisiana Equine Promotion and
6 Research Fund; to provide for the transfer, deposit, and use of monies in the fund;"

7 AMENDMENT NO. 3

8 On page 2, line 8, after "**shall be**" delete the remainder of the line and delete lines 9 through
9 11 and insert the following:

10 **"credited to the Louisiana Equine Promotion and Research Fund as**
11 **established by R.S. 39:100:241."**

12 AMENDMENT NO. 4

13 On page 2, after line 12, insert the following:

14 "Section 2. Subpart CC of Part II-A of Chapter 1 of Subtitle I
15 of Title 39 of the Louisiana Revised Statutes of 1950, to be comprised of
16 R.S. 39:100.241, is hereby enacted to read as follows:

17 **SUBPART CC. LOUISIANA EQUINE PROMOTION AND RESEARCH FUND**

18 **§100.241. Louisiana Equine Promotion and Research Fund**

19 **A. There is hereby created, as a special fund in the state treasury,**
20 **the Louisiana Equine Promotion and Research Fund, hereafter referred**
21 **to in this Section as the "fund".**

22 **B.(1) After compliance with the requirements of Article VII,**
23 **Section 9(B) of the Constitution of Louisiana, the fund shall consist of**
24 **monies deposited into the fund pursuant to the requirements of R.S.**
25 **27:625(G)(7) and any other monies appropriated annually by the**
26 **legislature including donations, gifts, grants, or any other monies which**
27 **may be provided by law.**

28 **(2) Monies in the fund shall be invested by the treasurer in the**
29 **same manner as monies in the state general fund, and interest earned on**
30 **investment of the monies shall be credited to the fund. All unexpended**
31 **and unencumbered monies in the fund at the end of the fiscal year shall**
32 **remain in the fund.**

33 **C. Monies in the fund shall be appropriated to the Department**
34 **of Agriculture and Forestry for the Louisiana Equine Promotion and**
35 **Research Program in accordance with the provisions of R.S. 3:2076 and**
36 **2077."**
