Provides relative to the Louisiana Agricultural Chemistry and Seed Commission. (gov sig)

Present law provides for the responsibilities of the State Chemist including determining annually the values per pound of nitrogen, available phosphoric acid, potash, and any other substance claimed to have value as a fertilizer, and determining the value of protein and any other substance guaranteed as a commercial feed. Proposed law provides that a commercial feed will be deemed adulterated if it does not comply with the Code of Federal Regulations and the Federal Food, Drug, and Cosmetic Act (FFDCA). Present law states that feed will be adulterated if it contains any drug or antibiotic; proposed law clarifies that the antibiotic contained in the feed must be one defined by the FFDCA and removes the criteria that any antibiotic will cause feed to be adulterated. Present law provides that the inspection of commercial feed may include the verification of such records and production process to determine compliance with current manufacturing practices; proposed law adds that the Seed commission can adopt the good manufacturing practices regulations in accordance with Federal regulations. Finally, Proposed law creates a new deficiency assessment for guarantees not listed in current law which cannot exceed 10% of the commercial feed purchase price. Proposed law codifies current practices to make them consistent with federal law.

The proceeds of a deficiency assessment is paid to the purchaser of the feed if they are identifiable, otherwise it is paid to LDAF which is deposited into the Feed and Fertilizer Fund. The frequency in which these deficiency assessments will occur and the amounts of these assessments are indeterminable.
