SENATE RESOLUTION NO. 47

WORKFORCE DEVELOPMENT. Creates the Louisiana Opportunity Youth Task Force.

1	A RESOLUTION
2	To create and provide for the Louisiana Opportunity Youth Task Force.
3	WHEREAS, according to the latest United States Census, almost one in five
4	Louisianians live in poverty and one in four children in the state grow up in poverty, and
5	sizeable inequality and disparities remain, especially for Louisiana's disconnected youth; and
6	WHEREAS, an "opportunity youth" is defined as a person between the ages of
7	sixteen and twenty-four years who is not enrolled in school, does not work, or is a teen or
8	young adult involved with the foster care, juvenile justice, or homeless systems; and
9	WHEREAS, opportunity youth facing socioeconomic and systemic barriers are
10	oftentimes disconnected from education and workforce training opportunities, preventing
11	young people of color, especially, from accessing Louisiana's prosperity; and
12	WHEREAS, the cost of failing young people at this critical juncture in their lives has
13	significant long-term costs to them as individuals and to society at large; and
14	WHEREAS, the White House Council for Community Solutions commissioned a
15	study entitled, "The Economic Value of Opportunity Youth", estimating that in the year 2011
16	alone taxpayers "shouldered more than \$93 billion to compensate for lost taxes and direct
17	costs to support young people disengaged from both education and work," while the
18	long-term societal costs were projected to be \$4.7 trillion over their lifetimes; and

1	WHEREAS, data collected from the 2021 American Community Survey (ACS) of
2	the U.S. Census shows that there were 4.7 million disconnected youth nationwide, or about
3	one in eight young people; and
4	WHEREAS, Louisiana has the second-highest youth disconnection rate in the
5	country, with 17.7 percent (96,000) of youth sixteen to twenty-four years of age neither in
6	school nor at work, compared to 12.1 percent nationally; and
7	WHEREAS, the latest ACS data indicates that nationally in 2021, fifteen percent
8	(307,954) of youth sixteen to nineteen years of age were not in school in the previous three
9	months and 38.4 percent of young adults twenty to twenty-four years of age were
10	unemployed (8.9 percent or 225,942); and
11	WHEREAS, research shows that more than twenty-five percent, or about 745,214,
12	of Louisiana's youth is not a part of the labor force at all; and
13	WHEREAS, in Louisiana in 2020, opportunity youth were 1.7 times more likely to
14	live below the poverty line as connected youth, disconnected women were three times more
15	likely to be mothers as their connected peers, and over ten percent of disconnected youth and
16	twenty-five percent of disconnected young Black men are living in an institution; and
17	WHEREAS, a greater proportion of Louisiana's opportunity youth were living in
18	poverty relative to their connected peers (37.1 percent and 22.9 percent, respectively) and
19	over one-half of the state's opportunity youth (19 to 24 years of age) has no education
20	beyond a high school diploma, relative to their connected peers (50.7 percent and 28.5
21	percent, respectively); and
22	WHEREAS, opportunity youth face unique employment, education, and training
23	barriers that often do not align with efforts that center adults; and
24	WHEREAS, in Louisiana, 2021 ACS data indicates the rate of disconnection among
25	Black youth (27.9%) was more than twice that of white youth (11.3%); and
26	WHEREAS, Black and Latino adolescents are not only disproportionately more
27	likely to come from low-income households and have experienced past trauma, but are faced
28	with discrimination that can derail their physical and mental well-being; and
29	WHEREAS, despite declines in youth incarceration, significant gaps remain as youth
30	of color are over-represented in our criminal justice system; and

1	WHEREAS, prioritizing opportunity youth will not only expand their education and
2	workforce opportunities, but also expand the pool of talent that employers can access to meet
3	their workforce needs, while averting the societal costs associated with disconnection.
4	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
5	does hereby establish and provide for the Task Force on Louisiana's Opportunity Youth to
6	study ways of improving the lives of this population, and to propose recommendations,
7	together with specific proposals for legislation, if the task force deems it necessary and
8	appropriate.
9	BE IT FURTHER RESOLVED that the task force should include consideration of
10	the following:
11	(1) Funding for education and workforce training programs that center opportunity
12	youth and create pathways to good jobs.
13	(2) Expansion of innovative "earn and learn" opportunities, including
14	apprenticeships, pre-apprenticeships, and other work-based learning opportunities.
15	(3) Advancement of dual enrollment implementation, which allows opportunity
16	youth to earn college credit while earning their high school equivalency.
17	(4) Ensure that opportunity youth will be included in research conducted by the
18	Kathleen Babineaux Blanco Public Policy Center.
19	(5) The protection and strengthening of social safety net investments for opportunity
20	youth that support basic needs such as food, housing, internet access, transportation,
21	childcare, health, and mental health care, enabling them to complete their education and
22	training goals, including removing barriers to accessing student financial aid programs.
23	BE IT FURTHER RESOLVED that the task force shall consist of the following
24	members:
25	(1) The secretary of the Louisiana Workforce Commission (LWC), or her
26	designee, and one additional staff member having knowledge of workforce
27	programming.
28	(2) The superintendent of the Louisiana Department of Education, or his
29	designee.
30	(3) The president of Louisiana's Community and Technical Colleges (LCTCS),

1	or his designee.
2	(4) Two members of the Louisiana Opportunity Youth Coalition.
3	(5) The executive director of the Kathleen Babineaux Blanco Public Policy
4	Center, or his designee.
5	(6) The secretary of the Louisiana Department of Health (LDH), or his designee.
6	(7) The secretary of the Department of Children and Families (DCFS), or his
7	designee.
8	(8) Lived experts of Louisiana's opportunity youth population current or past.
9	BE IT FURTHER RESOLVED that each designating authority shall submit the
10	names of designees to the task force to the Louisiana Workforce Commission no later than
11	August 15, 2024.
12	BE IT FURTHER RESOLVED that the Louisiana Workforce Commission shall
13	provide staff support as needed by the task force.
14	BE IT FURTHER RESOLVED that no later than September 15, 2024, the secretary
15	of the Louisiana Workforce Commission shall convene the first meeting of the task force,
16	at which the members may elect a chairman, vice chairman, and other officers as the task
17	force deems appropriate.
18	BE IT FURTHER RESOLVED that in conducting this study, the task force may seek
19	input and advice from any interested stakeholder, including: individuals who have personal
20	experience with the target population; direct service providers; opportunity youth current and
21	past.
22	BE IT FURTHER RESOLVED that a majority of the task force shall constitute a
23	quorum for the transition of business, and all official actions of the task force shall require
24	the affirmative vote of a majority of members.
25	BE IT FURTHER RESOLVED that the members of the task force shall serve
26	without compensation, except per diem or expenses reimbursement to which they may be
27	individually entitled as members of their constituent organizations.
28	BE IT FURTHER RESOLVED that the Task Force on Louisiana Opportunity Youth
29	may submit its findings and recommendations, if any, in the form of a written report to the
30	secretary of the Louisiana Workforce Commission, the Senate and House committees on

- 3 than February 1, 2025.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the secretary of the Louisiana Workforce Commission, the secretary of the Louisiana Department of Health, the secretary of the Department of Children and Families, the superintendent of the Louisiana Department of Education, the president of Louisiana's Community and Technical Colleges, the executive director of the Kathleen Babineaux Blanco Public Policy Center, and the Louisiana Opportunity Youth Coalition.

Duplessis

Creates the Louisiana Opportunity Youth Task Force to study ways to expand the education and workforce opportunities for opportunity youth, and to propose recommendations, together with specific proposals for legislation, if the task force deems it necessary or appropriate.

Provides that the task force consist of the following members:

- (1) The secretary of the La. Workforce Commission (LWC), or her designee, and one additional staff member having knowledge of workforce programming.
- (2) The superintendent of the La. Dept. of Education, or his designee.
- (3) The president of La.'s Community and Technical Colleges (LCTCS), or his designee.
- (4) Two members of the La. Opportunity Youth Coalition.
- (5) The executive director of Kathleen Babineaux Blanco Public Policy Center, or his designee.
- (6) The secretary of the La. Dept. of Health (LDH), or his designee.
- (7) The secretary of the Dept. of Children and Families (DCFS), or his designee.
- (8) Lived experts of Louisiana's opportunity youth population current or past.

Provides relative to meetings of the task force, quorum, voting, and staffing.

Provides that the task force may make a written report of its findings and recommendations by February 1, 2025.
