## COMMENDATIONS: Commends Gloria Mae Bryant-Banks on the occasion of her ninetieth birthday

1	A RESOLUTION
2	To commend Gloria Mae Bryant-Banks on the occasion of her ninetieth birthday.
3	WHEREAS, Gloria Mae Bryant-Banks was born to Eugene and Ethel Barnes Bryant;
4	she was raised in a Christian home in Central City New Orleans and began her education at
5	Thomy Lafon Elementary School in the Orleans Parish Public School System; and
6	WHEREAS, Gloria attended Gilbert Academy High School for her freshman year,
7	after which she transferred to Gaudet Episcopal High School, where she graduated as
8	valedictorian of her class in 1952; and
9	WHEREAS, after receiving her diploma, Gloria received a scholarship from the New
10	Orleans Alumnae Chapter of Delta Sigma Theta Sorority, Incorporated, to continue her
11	studies at Dillard University, where she completed her degree program early and graduated
12	in 1956; and
13	WHEREAS, Gloria began graduate studies at the Atlanta University School of Social
14	Work before returning to New Orleans to continue her studies at the Tulane University
15	School of Social Work in the fall semester of 1963; in June 1964, she received a Master of
16	Social Work degree and became the first black student to graduate from Tulane University;
17	she further added to her social work credentials by obtaining certification from the Academy
18	of Certified Social Workers and by becoming a board-certified social worker; and
19	WHEREAS, Ms. Bryant-Banks dedicated the entirety of her professional career in
20	service to the state of Louisiana; she began as a trainee of the formerly-named Department
21	of Social Services, and thirty-six years later, she retired as the secretary for the Department

- of Children and Family Services; during her inspiring career, she served as the only black
   woman, and one of only two women, in Governor Edwin Edwards's cabinet; she was also
   recognized in 2022 by the Tulane University School of Social Work as a trailblazer for her
   roll in creating a more inclusive and diverse academic community at Tulane; and
- 5 WHEREAS, outside of her astonishing professional life, Gloria is a seventy-year 6 member of the Beta Gamma Chapter of Delta Sigma Theta Sorority, Incorporated; she is a 7 member of the New Orleans Alumnae Chapter and has served the organization at the local, 8 regional, and national levels; she is recognized for using her immense knowledge and 9 experience to help create the organization's book on protocol and traditions; and

WHEREAS, Ms. Bryant-Banks is the proud mother of two sons, Jay H. Banks and Gralen Bryant-Banks, and she is a doting grandmother and great-grandmother; she is a lifelong member of New Zion Baptist Church, and she currently serves as a trustee and president of the Trojan's Ministry; she served her church as a teacher and lecturer at the local, state, and national levels of the Women's Auxiliary of the National Baptist Convention; and

WHEREAS, Gloria Bryant-Banks is a truly inspiring woman who is most deserving
of the highest recognition for her outstanding achievements in the field of social work and
for her incredible civic involvement throughout her life.
