Provides for prescribed burning by non-certified prescribed burn managers. (gov sig)

Proposed law provides that any prescribed burning conducted by non-certified prescribed burn managers outside of adherence with present law must submit the location, date, and time of the prescribed burn whether in person or by phone to the Office of Forestry. Additionally, proposed law clarifies that a non-certified prescribed burn manager means an individual that has not completed the certification program of the Louisiana State University Agricultural Center or other Louisiana Department of Agriculture and Forestry approved program. This proposed law does not apply to the burning of a leaf pile, yard debris, or hand-piled natural vegetation.
