CONSERVATION. Provides for boundaries of the Amite River Basin Drainage and Water Conservation District. (8/1/24)

1 AN ACT

2 To amend and reenact R.S. 38:3301(A), relative to the Amite River Basin Drainage and  
3 Water Conservation District; to provide for the geographical boundaries of the  
4 district; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 38:3301(A) is hereby amended and reenacted to read as follows:

7 §3301. Limits of district; limits of Comite River Diversion Canal Impact Area

8 A. The Amite River Basin Drainage and Water Conservation District is  
9 hereby created. The district shall be comprised of that geographical area within the  
10 watershed limits of the Amite River and Tributaries Basin more particularly  
11 described as follows:

12 Starting at the northwest corner of Section 64, T1S-R1E, in East Feliciana  
13 Parish and also point in the State line between the States of Louisiana and  
14 Mississippi and POINT OF BEGINNING proceed in a southwesterly direction along  
15 the western boundary of Section 64, T1S-R1E to a point and corner of Section 64,  
16 T1S-R1E; thence proceed in an easterly direction along the southern boundary of  
17 Section 64, T1S-R1E to a point and corner of Section 64, T1S-R1E; thence proceed

1 in a southerly direction along the boundary line of Section 64, T1S-R1E to a point  
2 and corner of Section 64, T1S-R1E; thence proceed in an easterly direction along the  
3 southern boundary line of Section 64, T1S-R1E to a point and intersection with the  
4 eastern right-of-way line of the Illinois Central Gulf Railroad; thence proceed in a  
5 southerly direction along the eastern right-of-way line of the Illinois Central Gulf  
6 Railroad to the point of intersection with the northern town limits of the Town of  
7 Wilson; thence proceed in an easterly direction along the northern town limits of the  
8 Town of Wilson and follow the town limits of the Town of Wilson to a point and  
9 intersection with the southern boundary line of Section 44, T1S-R1E; thence proceed  
10 in a westerly direction along the southern boundary line of Section 44, T1S-R1E to  
11 a point and corner of Section 44, T1S-R1E; thence proceed in a southwesterly  
12 direction along the southern boundary line of Section 45, T1S-R1E to a point and  
13 southwestern corner of Section 45, T1S-R1E; thence proceed in a southwesterly  
14 direction along the southeastern boundary line of Section 46, T1S-R1E to a point and  
15 northern corner of Section 53, T1S-R1E; thence proceed in a southwesterly direction  
16 along the western boundary of Section 53, T1S-R1E to a point and western corner  
17 of Section 53, T1S-R1E; thence proceed in a southeasterly direction along the  
18 southern boundary line of Section 53, T1S-R1E to a point and intersection with the  
19 western corner of Section 83, T2S-R1E; thence proceed in a southeasterly direction  
20 along the southern boundary line of Section 83, T2S-R1E to a point and intersection  
21 with the northwestern boundary line of Section 64, T2S-R1E; thence proceed in a  
22 southwesterly direction along the northeastern boundary line of Section 64, T2S-R1E  
23 to a point and southwest corner of Section 64, T2S-R1E; thence proceed in a  
24 southeasterly direction along the southern boundary line of Section 64, T2S-R1E to  
25 a point and southern corner of Section 64, T2S-R1E; thence proceed in a  
26 southeasterly direction along the southwestern boundary line of Section 70, T2S-R1E  
27 to a point and southern corner of Section 70, T2S-R1E; thence proceed in a  
28 northeastern direction along the southern boundary line of Section 70, T2S-R1E to  
29 a point and intersection with the eastern right-of-way line of the Illinois Central Gulf

1 Railroad; thence proceed in a southern direction along the eastern right-of-way line  
2 of the Illinois Central Gulf Railroad to a point and intersection with the southern  
3 boundary line of Section 69, T2S-R1E; thence proceed in a westerly direction along  
4 the southern boundary of Section 69, T2S-R1E to a point and corner of Section 69,  
5 T2S-R1E; thence proceed in a southerly direction along the boundary line of Section  
6 69, T2S-R1E to a point and corner of Section 69, T2S-R1E; thence proceed in a  
7 westerly direction along the southern boundary line of Section 69, T2S-R1E to a

17 in a southern direction along the St. Helena Meridian to a point and intersection with  
18 the northeastern boundary line of Section 47, T2S-R1W; thence proceed in a  
19 northwesterly direction along the northeastern boundary line of Section 47,  
20 T2S-R1W to a point and eastern right-of-way boundary line of Louisiana State  
21 Highway 68; thence proceed in a southwesterly direction along the eastern  
22 right-of-way line of Louisiana State Highway 68 to a point and point of intersection  
23 with the southern right-of-way boundary line of Louisiana State Highway 10; thence  
24 proceed in a southeasterly direction along the southern right-of-way line of Louisiana  
25 State Highway 10 to a point and intersection with the southeastern boundary line of  
26 Section 60, T2S-R1W; thence proceed in a southwesterly direction along the  
27 southeastern boundary line of Section 60, T2S-R1W to a point and corner of Section  
28 60, T2S-R1W; thence proceed in a northwesterly direction along the boundary line  
29 of Section 60, T2S-R1W to a point and corner of Section 60, T2S-R1W; thence

1 proceed in a southwesterly direction along the boundary line of Section 60,  
2 T2S-R1W to a point and northeastern corner of Section 39, T3S-R1W; thence  
3 proceed in a southeasterly direction along the southeastern boundary line of Sections

5 T3S-R1W; thence proceed in a southeasterly direction along the northern boundary
