2 On page 2, line 10, after "1950" and before the period "." insert "**or as provided in criteria**  
3 **established in the guidance promulgated pursuant to this Section**"

4 AMENDMENT NO. 2

5 On page 3, line 2, after "**commission**" and before "**and a House**" insert "**selected by the**  
6 **president of the Senate**"

7 AMENDMENT NO. 3

8 On page 3, line 3, after "**commission**" and before "**shall**" insert "**selected by the speaker**  
9 **of the House of Representatives**"

10 AMENDMENT NO. 4

17 **receive the same reimbursement of travel expenses for attending the**  
18 **meetings as is allowed for state employees' travel, except all legislative**  
19 **members of the commission shall receive the same per diem and travel**  
20 **expenses for attending meetings of the commission or any meeting**  
21 **thereof as is normally provided for members of the legislature."**
