

**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Civil Law and Procedure to Reengrossed Senate Bill No. 355 by Senator Stine

1 AMENDMENT NO. 1

2 On page 2, delete lines 7 through 28 in their entirety and insert the following:

3 **"(1) "Foreign entity" means an entity that is (a) owned or controlled by**  
 4 **the government of a foreign country of concern, or (b) a partnership,**  
 5 **association, corporation, organizing or other combination of persons organized**  
 6 **under the law of or having its principal place of business in a foreign country**  
 7 **of concern, or a subsidiary of such entity.**

8 **"(2) "Foreign country of concern" means a foreign government listed in**  
 9 **15 CFR 7.4, including any agency of or any other entity of significant control of**  
 10 **such foreign country of concern."**

 22 "**entity**"

24 On page 3, at the beginning of line 23, change "(9)" to "(7)"

26 On page 4, line 24, after "**by foreign**" delete the remainder of the line and delete line 25 in  
 27 its entirety and insert "**entities**"

28 AMENDMENT NO. 9

29 On page 4, line 29, delete "**person, foreign state, or foreign sovereign wealth fund**" and  
 30 insert "**entity**"

2 On page 5, line 3, after "**foreign**" delete the remainder of the line and on line 4, delete  
3 "**foreign state, or foreign sovereign wealth fund**" and insert "**entity**"

4 AMENDMENT NO. 11

5 On page 5, line 9, after "**foreign**" delete the remainder of the line and on line 10, delete  
6 "**foreign state, or foreign sovereign wealth fund**" and insert "**entity**"

7 AMENDMENT NO. 12

8 On page 6, line 13, after "**a foreign**" delete the remainder of the line and delete line 14 in its  
9 entirety and insert "**entity.**"

11 On page 7, line 13, after "**any foreign**" and before "**and**" delete "**person, foreign state, or**  
12 "**foreign sovereign wealth fund**" and insert "**entity**"
