Amendments proposed by House Committee on Civil Law and Procedure to Engrossed Senate Bill No. 75 by Senator Morris

1 AMENDMENT NO. 1

2 On page 3, line 4, after "**document**" and before "**shall**" insert "**or exhibit**"

3 AMENDMENT NO. 2

4 On page 3, line 5, after "**document**" and before "**shall**" insert "**or exhibit**"

5 AMENDMENT NO. 3

6 On page 8, line 12, after "of" delete the remainder of the line

7 AMENDMENT NO. 4

8 On page 8, line 16, after "and" and before "return" delete "may thereafter" and insert "**shall**"

9 AMENDMENT NO. 5

10 On page 8, delete line 17 in its entirety and insert "**indicated person and to the address**  
 11 **shown on the first page of the record, or if no such person and address is indicated, to**  
 12 **any vendee or other transferee whose name and address are stated in the instrument.**  
 13 **The clerk shall verify that the copy of the record is complete and legible prior to the**  
 14 **return or disposal of the original record.**"

15 AMENDMENT NO. 6

16 On page 8, line 23, after "**records**" and before the comma "," insert "**on or prior to**  
 17 **December 31, 2004**"

18 AMENDMENT NO. 7

19 On page 8, line 25, after "who" delete the remainder of the line and delete lines 26 through  
 20 27 in their entirety and on line 28, delete "in this Section." and insert the following:

21 **" is indicated and to the address shown on the first page of the record, or**  
 22 **if no such person and address is indicated, to the person who presented the**  
 23 **record after the clerk of court has done all of the following:**

24 **(a) Received certification from the state archivist that the records are**  
 25 **not subject to R.S. 44:406 or 411.**

26 **(b) Preserved the record as provided in this Section.**

27 **(c) Verified that the copy of the record is complete and legible."**

28 AMENDMENT NO. 8

29 On page 9, line 5, after "**original**" and before "**of**" insert "**or, when permitted by R.S.**  
 30 **44:116, a complete and legible copy**"

31 AMENDMENT NO. 9

32 On page 9, line 6, after the period "." delete the remainder of the line and delete line 7 in its  
 33 entirety

1 AMENDMENT NO. 10

2 On page 9, after line 13, add the following:

3 "Section 6. Nothing in this Act shall be construed to create a cause of action against  
4 a clerk of court for destruction or disposition of records prior to the effective date of  
5 this Act in accordance with the law in effect at the time of the destruction or  
6 disposition."
