1 A RESOLUTION

2 To commend Ryan L. Williams for his advocacy for mental health and his community
3 service.

4 WHEREAS, Ryan L. Williams is the CEO of Seedlinks Behavior Management LLC
5 in Shreveport, Louisiana; he was raised in the city's MLK community and graduated from
6 Green Oaks High School in 2002; he received a bachelor's degree in political science and
7 pre-law from Grambling State University and a master's degree in human services and
8 counseling from Louisiana Tech University; and

9 WHEREAS, Mr. Williams is a United States Air Force veteran who supported
10 missions in Iraq and Afghanistan; he was stationed at Seymour Johnson Air Force Base in
11 North Carolina, where he worked on and maintained E-15E Strike Eagles; and

12 WHEREAS, Mr. Williams is a role model for the youth in his community; he serves
13 as an advisor for Guide Right Youth Mentorship, a Kappa League director, vice-polemarch
14 of the Bossier City Alumni Chapter of Kappa Alpha Psi, Inc., and president of All Pro Dads;

16 WHEREAS, Mr. Williams recently became a trust-based relational interventionist
17 practitioner through the Karyn Purvis Institute of Child Development at Texas Christian
18 University in Fort Worth, Texas; additionally, his company was recognized as the 2018
19 Greater Shreveport Chamber of Commerce Emerging Business of the Year; and

20 WHEREAS, Ryan is an active volunteer in the city of Shreveport and has given more
21 than one hundred hours of community service; his efforts included facilitating and

1 organizing the "Classic Man Event" at Werner Park Elementary and speaking to Lakeshore
2 Middle School during back-to-school night; he also organized the State of Black Shreveport
3 Youth Summit and the C.A.P. Foundation Fundraiser; he also advocates for increasing the
4 number of registered voters in the city.
