12 survivor for injuries related to the sexual assault."

4 **provides a copy of all notices sent to stakeholders about the sexual response plan**
5 **meeting, a list of the individuals and organizations that were provided notice,**
6 **the method and timing of the notice provided, and a list of the individuals and**
7 **organizations in attendance at the meeting.**

8 **"(6) The department shall record all meetings and make the recordings**
9 **and annual plans available through the Louisiana Department of Health's**
10 **website."**

25 survivors are"
