

HOUSE SUMMARY OF SENATE AMENDMENTS**HB 641****2024 Regular Session****Knox**

MTR VEHICLE/LICEN PLATES: Creates specialty license plates

Synopsis of Senate Amendments

1. Changes "Support Our Wildlife Rehabilitators" to "Support Wildlife Rehabilitation"
2. Changes the entity that the secretary is to work in conjunction with to select the color and design of the "Support Wildlife Rehabilitation" plate from the Wildlife Rehabilitators Support Council to the NOLA Wildlife Center.
3. Changes the entity that will receive the royalty fee from the council to the NOLA Wildlife Center and specifies it may be distributed in the form of grants to licensed wildlife rehabilitators or licensed wildlife rehabilitation centers.
4. Requires the Department of Public Safety and Corrections issue a special prestige license plate to be known as the "St. Thomas Aquinas" and "Evangel Christian Academy" specialty license plates, provided there are a minimum of one hundred applicants for each plate, instead of one thousand.
5. Specifies that the secretary of the Department of Public Safety and Corrections is to establish a special prestige motor vehicle license plate to be known as the "Leesville High School Alumni" plate.
6. Makes technical changes.

Digest of Bill as Finally Passed by Senate

Proposed law requires monies from the "3" for Cyclists" special license plate royalty fee be used solely to assist the Metro Bicycle Coalition of New Orleans.

Proposed law requires the monies from the "Support Wildlife Rehabilitation" plates be used to assist with the costs of wildlife rehabilitation and for grants to licensed wildlife rehabilitators and licensed wildlife rehabilitation centers.

Proposed law requires monies from the "St. Thomas Aquinas" specialty license plate be solely used to assist the administration.

Proposed law requires monies from the "Evangel Christian Academy" plate be used solely to assist the school.

Proposed law requires monies from "United States Submarine Veterans" be used to provide scholarships for children.

Proposed law requires monies from "Leesville High School Alumni" be used to provide scholarships.

Proposed law requires monies from "Humane Society of Louisiana" be used to fund spay and neuter programs to help with current overpopulation of animals.

Proposed law requires the Dept. of Public Safety and Corrections issue special prestige license plates to be known as the "3' for Cyclists", "Support Wildlife Rehabilitation", "St.

Thomas Aquinas", "Evangel Christian Academy", "United States Submarine Veterans", "Leesville High School Alumni", and "Humane Society of Louisiana" specialty license plates, provided there is a minimum of 1,000 applicants for each plate.

Proposed law requires the Dept. of Public Safety and Corrections issue special prestige license plates to be known as the "St. Thomas Aquinas" specialty license plate, provided there is a minimum of 100 applicants for the plate.

Proposed law requires that the secretary work in conjunction with the Metro Bicycle Coalition of New Orleans to select the color and design of the "3' for Cyclists" plate. Further requires the design include the words "3' for Cyclists".

Proposed law requires that the secretary work in conjunction with the NOLA Wildlife Center to select the color and design of the "Support Wildlife Rehabilitation" plate. Further requires the design to include an image or logo of a wild animal, and include the words "Support Wildlife Rehabilitation".

Proposed law requires the secretary work in conjunction with St. Thomas Aquinas Catholic school to select the color and design of the "St. Thomas Aquinas" plate. Further requires the design to include the words "St. Thomas Aquinas".

Proposed law requires that the secretary work in conjunction with Evangel Christian Academy administration to select the color and design of the "Evangel Christian Academy" plate. Further requires the design to include the words "Evangel Christian Academy".

Proposed law requires the secretary to work in conjunction with the United States Submarine Veterans Charitable Foundation, Inc., to select the color and design of the United States Submarine Veterans" plate. Further requires the design to include the words "United States Submarine Veterans".

Proposed law requires the secretary to work in conjunction with the Alumni Association Executive Board, to select the color and design of the "Leesville High School Alumni" plate. Further requires the design include the words "Leesville High School Alumni".

Proposed law requires the secretary to work in conjunction with the Humane Society of Louisiana, to select the color and design of the "Humane Society of Louisiana" plate. Further requires the design include the words "Humane Society of Louisiana".

Proposed law specifies that the license plates be issued, upon application, to any citizen of La. in the same manner as any other motor vehicle license plate.

Proposed law requires the department to collect an annual royalty fee of \$25 in addition to the standard motor vehicle license tax and a \$3.50 handling fee for each plate to be retained by the department to offset a portion of administrative costs.

Proposed law requires the secretary to promulgate and adopt rules and regulations to implement the provisions provided in proposed law.

Directs the Dept. of Public Safety and Corrections, office of motor vehicles, to create the "3' for Cyclists", "Support Wildlife Rehabilitation", "St. Thomas Aquinas", "Evangel Christian Academy", "United States Submarine Veterans", "Leesville High School Alumni", and "Humane Society of Louisiana" speciality license plates when the applicable statutory provisions are met and its system is updated to accommodate the creation of new plates.
