**HOUSE RESOLUTION NO. 226**

COMMENDATIONS: Commends the Louisiana Probation and Parole Officers Association for fifty years of distinguished service

A RESOLUTION

2 To commend the Louisiana Probation and Parole Officers Association for fifty years of 3 distinguished service. 4 WHEREAS, the Louisiana Probation and Parole Officers Association's (LPPOA) 5 purpose is to promote professional development, education, and recognition in the field of 6 community corrections; the association is committed to increasing officers' quality of life 7 by advocating for a positive work environment, appropriate compensation, and benefits 8 befitting the jobs they are tasked to perform; and 9 WHEREAS, LPPOA advocates on behalf of members to the Legislature of 10 Louisiana, officer of the governor, the Department of Public Safety and Corrections, and 11 other public and community stakeholders to influence policy and planning; LPPOA 12 promotes and improves public safety through law enforcement and reentry efforts; and 13 WHEREAS, according to Louisiana law, probation and parole officers are 14 commissioned law enforcement officers with powers of arrest and statewide jurisdiction; and 15 WHEREAS, probation and parole officers supervise approximately 45,000 16 individuals convicted of felony crimes who are either placed on probation or released from 17 incarceration via parole on community supervision; and 18 WHEREAS, probation and parole officers provide presentence investigations to the 19 district courts, preparole and clemency investigations to the Board of Pardons and 20 Committee on Parole; these investigations are utilized by the courts to make informed 21 decisions with regard to sentencing individuals convicted of felony crimes; the Board of 1

Pardons and Committee on Parole utilize investigations to make informed decisions 2 concerning the possible early release of individuals; clemency investigations are utilized by 3 the governor to make informed decisions about whether or not to grant clemency; and 4 WHEREAS, probation and parole officers are tasked with assisting formerly incarcerated individuals who are reentering society; they have organized and actively 5 6 participated in local reentry coalitions and they strive to remove barriers to successful 7 reentry; and 8 WHEREAS, probation and parole officers assist other local, state, and federal law 9 enforcement agencies in the investigation and apprehension of individuals engaged in 10 criminal activity; they participate in local, state, and federal task forces; and 11 WHEREAS, probation and parole officers are a key component of specialty courts 12 throughout the state; officers supervise individuals participating in DWI courts, drug courts, 13 reentry courts, mental health courts, and veterans courts; and 14 WHEREAS, probation and parole officers have assisted with staffing office of 15 juvenile justice facilities to prevent escapes and protect public safety; and 16 WHEREAS, probation and parole officers were called upon during the COVID-19 17 pandemic to conduct hospital sits on inmates who were COVID positive; officers staffed the 18 COVID-19 quarantine unit at the Louisiana State Penitentiary at Angola; officers continue 19 to provide hospital sit duties to insure the safety, security, and smooth operation of adult 20 correctional facilities; and 21 WHEREAS, probation and parole officers are increasingly called upon during times 22 of natural disaster such as floods and hurricanes to provide assistance with rescue and law 23 enforcement duties; they were present before, during, and after hurricanes Katrina, Rita, 24 Gustav, and Ike and historic flooding in the Baton Rouge and Denham Springs areas. 25 THEREFORE, BE IT RESOLVED that the House of Representatives of the 26 Legislature of Louisiana does hereby commend the Louisiana Probation and Parole Officers 27 Association for fifty years of distinguished service and does hereby extend enduring 28 gratitude for its support of Louisiana's probation and parole officers and their part in 29 securing the public safety of all Louisianans.
