Unless otherwise specified, "licensed audiologist" shall not mean a person who has a provisional or restricted license issued under this Chapter. * * *
33 34 35	(7)(a) "Practice of audiology" means providing, or offering to provide, to individuals or groups of individuals who have, or are suspected of having, disorders of the auditory system, any service in audiology, including prevention, identification,

1	evaluation, interpretation, counseling, consultation, habilitation, rehabilitation,
2	instruction, supervision, and research. The practice of audiology shall also include
3	audiology services for disorders of the vestibular system upon referral of a physician.
4	An audiologist may engage in any task, procedure, act, or practice that is necessary
5	including but not limited to any of the following:
6	(i) For the evaluation Evaluation of hearing and the monitoring of neural
7	functioning.
8	(ii) For training Training in the use of amplification, including hearing aids
9	and assistive listening devices.
10	(iii) For the making Making of earmolds.
11	(iv) For the fitting, Fitting, dispensing, and selling of hearing aids.
12	(v) Conducting speech and language screening limited to a pass or fail
13	determination for the purpose of identifying and referring individuals suspected of
14	having disorders of communication.
15	(vi) Managing of cerumen which refers to the removal of wax-like secretions
16	from the cartilaginous portion of the external ear in otherwise healthy ears.
17	(vii) Any basic health screening with a referral to an appropriate healthcare
18	professional.

20	(g) The practice of audiology may include speech and language screening,
21	limited to a pass/fail determination for the purpose of identifying and referring
22	individuals suspected of having disorders of communication. A licensed audiologist
23	who fits and sells hearing aids shall follow rules adopted by the board regarding
24	hearing aid trial periods.

26	(13) "Over-the-counter hearing aid" means a hearing instrument or hearing
27	aid that meets the United States Food and Drug Administration's requirements for
28	this class of device and which may be dispensed or sold without a hearing
29	assessment, licensed hearing instrument professional fitting and dispensing
30	engagement, or returned for credit privileges as provided by federal law.
31	(14) "Personal sound amplification product" means an amplification device,
32	as defined by the United States Food and Drug Administration or Federal Trade
33	Commission, that is not labeled as a hearing aid and is not intended to treat hearing
34	loss.
35	(15) "Prescription hearing aid" means a hearing instrument or hearing aid
36	that meets the United States Food and Drug Administration's requirements for this
37	class of device and requires a hearing assessment and prescription prior to purchase
38	and a prescribed fitting and dispensing by a licensed audiologist or hearing
39	instrument professional.
