Purpose of Bill: The bill changes the allocation of local sales and use tax proceeds from event sales at the Angola State Penitentiary Prison Rodeo (Rodeo), decreasing the West Feliciana Parish School Board's (School Board) share from 66% to 20% and increasing the West Feliciana Council on Aging's (Council on Aging) share from 34% to 80%.

## **EXPENDITURE EXPLANATION**

This bill may increase School Board expenditures by \$330 for Fiscal Year 2025.

A School Board official indicated that this bill may increase School Board expenditures by \$330 for Fiscal Year 2025 for software programming to implement the tax allocation changes provided for by this bill.

## **REVENUE EXPLANATION**

This bill may decrease School Board sales tax revenue by approximately \$23,460 annually due to the reallocation of this revenue to the Council on Aging.

A School Board official indicated that, historically, the Rodeo's event sales generated an annual average of \$51,000 in sales tax from fiscal years 2019 to 2023, with the exception of 2021 when the rodeo was not held. Based on this data, the School Board's annual sales tax revenue from these event sales may decrease from \$33,660 (\$51,000 at 66%) to \$10,200 (\$51,000 at 20%), resulting in an annual revenue decrease of \$23,460 for the School Board.
