Proposed law provides for the allowable uses of any revenue or credits generated from the I-10 Calcasieu River Bridge public-private partnership, including windfall proceeds payments, distributions of tolls revenues, and toll credits; provides that prior to using revenues or credits, the secretary of the Department of Transportation and Development shall provide notice of the intended use and consult with the legislative delegation from the five parish area and receive approval for the use of funds from the Joint Legislative Committee on Transportation, Highways, and Public Works.
